MOTION FOR EXTENSION OF TIME TO ANSWER NOTICE OF OPPOSITION

LifeMax, LLC, a corporation duly organized and existing under the laws of Ohio, having its principle place of business at 251 West Garfield Road, Suite 200, Aurora, Ohio 44202, is the Applicant for the mark **THIN MINTS**, Serial No. 76/253,979. The Notice of Opposition was mailed on July 19, 2002. Therefore, the deadline for Applicant's answer to the Notice of Opposition is August 28, 2002.


On August 28, 2002, the undersigned contacted Thomas I. Rozsa, Esq. counsel for the Opposer. Mr. Rozsa agreed to extend the time to answer for an additional thirty days. Mr. Rozsa also agreed to extend all discovery and testimony periods for thirty days. On September 26, 2002, the undersigned contacted Mr. Rozsa again, and his office agreed to extend the time to answer for an additional thirty days. On October 25, 2002, the undersigned contacted Mr. Rozsa again, and he agreed to extend the time to answer, and all other dates, for an additional thirty days. The new deadline for Applicant to answer the Notice of Opposition will therefore be November 26, 2002. The remaining new time periods are as follows: Discovery period to close May 5, 2003; 30-day testimony period for party in position of plaintiff to close August 3, 2003;

30-day testimony period for party in position of defendant to close October 3, 2003; and 15-day rebuttal testimony period for plaintiff to close November 16, 2003.

The undersigned respectfully requests that the TTAB grant the Motion to Extend Time, as the Opposer has stipulated to the extension.




