
**REPLY BRIEF TO OPPOSER'S RESPONSE TO APPLICANT'S  
MOTION FOR SUMMARY JUDGMENT**

In its Response to Applicant's Motion for Summary Judgment, Opposer provides no evidence that creates a genuine issue of material fact. Opposer simply reiterates its unsupported claims of ownership of a mark for which it has no registration and for which it is unable to provide any evidence of use in connection with business and/or consulting services. Opposer's conclusory statements are inadequate to show an evidentiary conflict on the record. *See Levi Strauss & Co. v. Genesco, Inc.*, 742 F.2d 1401, 1404 (Fed. Cir. 1984). Thus, Applicant, Syntel, Inc. respectfully requests that its Motion for Summary Judgment be granted and that this Opposition be dismissed.


