**SECOND CONSENSUAL MOTION TO EXTEND TIME TO ANSWER OR
OTHERWISE RESPOND TO OPPOSITION, AND CORRESPONDING EXTENSION
OF DATES RELATIVE TO DISCOVERY AND TESTIMONY PERIODS**

The second extension of time is requested so that the parties may continue their ongoing discussions related to settlement of this matter.

This request for extension of time is not made for purposes of delay and it is respectfully requested that it be granted and that the time for filing an answer or otherwise responding to the opposition be extended to July 2, 2003.
