FOR SUMMARY JUDGMENT**

Opposer Microsoft Corporation ("Microsoft") hereby moves that this opposition proceeding be suspended with respect to all matters not germane to Microsoft's Motion for Summary Judgment and Motion to Amend the Notice of Opposition and, filed concurrently herewith, until the Board has had an opportunity to consider and rule on Microsoft's motions.

Suspension of this opposition proceeding pending the Board's decision on the Motion for Summary Judgment is appropriate under 37 C.F.R. § 2.127(d) in that the Motion for Summary Judgment is potentially dispositive of this proceeding.

Accordingly, Microsoft's instant motion to suspend and to reset as requested above should be granted.
