

**OPPOSERS' MOTION TO RESCHEDULE TESTIMONY PERIODS**

Opposers, Toyota Jidosha Kabushiki Kaisha and Toyota Motor Sales, U.S.A., Inc., move for a resetting of Plaintiffs' testimony period to open on February 15, 2007 and close thirty days later on March 17, 2007.

Under the requested schedule, Defendant's testimony period would open on April 16, 2007 and close on May 16, 2007, and Plaintiffs' rebuttal testimony period would open on June 15, 2007 and close on June 30, 2007.

The rescheduling is requested for several reasons. First, Opposers' counsel had major surgery on October 7, 2006 and is scheduled for a final follow-up procedure on December 19, 2006.
