Applicant further admits that Opposer has applied to register the mark "HUMAN RX" in International Class 35 "HUMAN RX", for "consulting services in the field of human resources", Ser. No. 78/137681, filed June 21, 2002. Applicant denies that its mark is or can be confusingly similar with Opposer's mark because the marks are distinctively different in appearance and sound when spoken, and are used by the parties in entirely different channels of commerce.

2. Opposer is the senior user of the mark "HUMAN RX" in commerce regulated by Congress.


ANSWER: Applicant has insufficient to admit or deny this allegation, and therefore denies the same.
