**APPLICANT'S REQUEST TO
RE-SET DISCOVERY AND TESTIMONY PERIODS**

1. On January 6, 2004, the Board instituted this proceeding, and issued an order setting dates for discovery and testimony periods. By that Order, discovery opened on January 26, 2004, and was set to close six months later, on July 24, 2004.
2. On March 4, 2004, the Board issued a new order setting discovery and testimony periods, re-setting the date for the close of discovery to May 4, 2004. This new discovery deadline would give the parties less than four months to complete discovery.
3. Applicant respectfully requests that the Board re-set the discovery, testimony, and trial dates based on the Board's original discovery deadline of July 24, 2004, to permit the parties the full six months to complete discovery.


