Opposers, Varsity Spirit Corporation, a Tennessee corporation having a business address of 6745 Lenox Center Court, Suite 500, Memphis, TN 38115; and Varsity Spirit Fashions & Supplies, Inc., a Minnesota corporation having a business address of 6745 Lenox Center Court, Suite 500, Memphis, TN 38115 (hereinafter "Varsity" or "Opposers") believe that they will be damaged by and hereby oppose the registration of said trademark. The grounds for opposition are as follows:

- 1. Applicant Headmaster, Inc. (hereinafter "Applicant") seeks to register "V VARSITY LEGENDS BY HEADMASTER, INC. & Design" as a trademark for use with respect to "clothing and headwear, namely, caps, hats and jerseys" in Class 25, based upon Applicant's intent-to-use the mark in commerce.
- 2. Opposers are and have for many years been engaged in the business of offering goods and services under the trade name "Varsity."
- 3. Opposers have used, since at least as early as April 10, 1978, and continue to use in commerce, the mark "VARSITY" for numerous products and services.
- 4. Long before Applicant's application filing date, Opposers have used the mark "VARSITY," in particular with regard to clothing and headwear.
- 5. One or more of Opposers are the owners of the following trademark registrations in the United States:

Opposers' trade name, common-law trademarks, trademark applications and trademark registrations are referred to hereinafter as the "VARSITY Family of Marks."

- 7. By virtue of Opposers' extensive use in commerce of the mark VARSITY in the United States, the relevant trade and public have come to associate goods and services bearing its VARSITY Family of Marks with Opposers.
- 8. Opposers' first use and/or registration of its VARSITY Family of Marks in connection with goods and services predates Applicant's filing date set forth in its application to register "V VARSITY LEGENDS BY HEADMASTER, INC. & Design" herein opposed.

- 9. The proposed goods of Applicant and the goods of Opposers, offered under the trademark "Varsity" are identical and/or substantially similar and/or related. Annexed as Exhibit A are copies of photographs of goods identical to those in Applicant's application being offered for sale in Opposer Varsity Spirit Fashion's 2002 catalogue.
- 10. Applicant's "V VARSITY LEGENDS BY HEADMASTER, INC. & Design" mark, as applied to the goods set forth in the application herein opposed, so resembles Opposers' VARSITY Family of Marks that it is likely to cause confusion, mistake and/or deception.
- 11. If Applicant is permitted to register "V VARSITY LEGENDS BY HEADMASTER, INC. & Design" for the goods set forth in the application, confusion of the trade and public is likely to result, such confusion resulting in damage and injury to Opposers.
- 12. Purchasers and potential purchasers, upon seeing Applicant's "V VARSITY LEGENDS BY HEADMASTER, INC. & Design" mark used in connection with its goods are likely to believe, in error, that such goods are offered in association or affiliation with or under license from Opposers.
- 13. If Applicant is permitted to register its mark for the goods set forth in the application herein opposed, confusion of the relevant trade and public resulting in damage and injury to Opposers would be likely to result. Any persons familiar with the goods of Opposers would be likely to assume that Applicant's goods are sponsored by or produced under license from or otherwise affiliated with Opposers. Furthermore, any objection to or fault found with Applicant's goods provided under its mark would necessarily reflect on and seriously injure the reputation that Opposers have established for its services and products sold under its VARSITY Family of Marks.

14. If Applicant were granted a registration for the mark herein opposed, it would obtain thereby at least a *prima facie* exclusive right to use the mark. Such registration would be a source of damage and injury to Opposers.

WHEREFORE, Opposers pray that registration of the mark of application No. 78/198,717 be refused and that this opposition be sustained.


