APPLICANT’S ANSWER TO OPPOSITION

Boot Royalty Company, L.P. (“Applicant”), a limited partnership organized under the laws of Delaware and having a principal place of business at 610 West Daggett Avenue, Fort Worth, Texas 76104, the owner of U.S. Application Serial No. 76/471,682 (“Applicant’s Mark”), for its Answer to Opposition filed by Converse, Inc. (“Opposer”), pleads and avers as follows:

1. Answering paragraph 1 of the Opposition, Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained therein and accordingly denies the allegations.
2. Answering paragraph 2 of the Opposition, Applicant admits the allegations contained therein.
3. Answering paragraph 3 of the Opposition, Applicant admits that Boot Royalty Company, L.P. is the owner of U.S. Trademark Application Serial No. 76/471,682 for the mark LAMA COMFORT TECHNOLOGY and Design (“the Application”). Applicant denies Opposer’s characterization of the Application

design as a five-point star design, but admits that one aspect of the design is a series of stylized five-point stars. Applicant admits that the Application is for “footwear, namely boots,” is in International Class 25, and was published in the United States Patent and Trademark Office Official Gazette on March 9, 2004 on TM page 89.

4. Answering paragraph 4 of the Opposition, Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained therein and accordingly denies the allegations.
5. Answering paragraph 5 of the Opposition, Applicant admits that the Trademark Electronic Search System (TESS) maintained by the U.S. Patent and Trademark Office currently reflects that Opposer is the owner of the listed United States trademark registrations. Applicant denies that U.S. Trademark Reg. No. 2,466,301 was registered on July 5, 2001, and denies that such registration relates to International Class 025. Applicant also denies that U.S. Trademark Reg. No. 2,529,040 relates to International Class 025. Applicant is without knowledge or information sufficient to form a belief as to whether the listed registrations are valid and/or in good standing and accordingly denies such allegation. Applicant denies any remaining allegations of paragraph 5.
6. Answering paragraph 6 of the Opposition, Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained therein and accordingly denies the allegations.

7. Answering paragraph 7 of the Opposition, Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained therein and accordingly denies the allegations.
8. Answering paragraph 8 of the Opposition, Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained therein and accordingly denies the allegations.
9. Answering paragraph 9 of the Opposition, Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained therein and accordingly denies the allegations.
10. Answering paragraph 10 of the Opposition, Applicant re-alleges and incorporates by reference the allegations of paragraph 1 through 9 as if fully set forth herein.
11. Answering paragraph 11 of the Opposition, Applicant admits that the Trademark Electronic Search System (TESS) maintained by the U.S. Patent and Trademark Office currently reflects that the dates of first use for the United States trademark registrations listed by Opposer in paragraph 5 are prior to the filing date of Applicant's Application. However, Applicant further admits that it is the owner of the following U.S. trademark registrations for the mark TONY LAMA and Design and that such design marks include a five-pointed star:

16. Answering paragraph 16 of the Opposition, Applicant re-alleges the answers of paragraphs 1 through 15 as if fully set forth herein.
17. Answering paragraph 17 of the Opposition, Applicant admits that the Trademark Electronic Search System (TESS) maintained by the U.S. Patent and Trademark Office currently reflects that the dates of first use for the United States trademark registrations listed by Opposer in paragraph 5 are prior to the filing date of Applicant's Application. However, Applicant further admits that it is the owner

of the following U.S. trademark registrations for the mark TONY LAMA and Design and that such design marks include a five-pointed star:

18. Answering paragraph 18 of the Opposition, Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained therein and accordingly denies the allegations.
19. Answering paragraph 19 of the Opposition, Applicant denies the allegations contained therein.
20. Answering paragraph 20 of the Opposition, Applicant denies the allegations contained therein.

AFFIRMATIVE DEFENSES

21. Applicant affirmatively alleges that during examination of the present application, U.S. Trademark Application Serial No. 76/471,682, the Trademark Examining Attorney searched the Office records and found no similar registered or pending mark which would bar registration under Trademark Act Section 2(d), 15 U.S.C. Section 1052(d); specifically, the Examining Attorney did not cite any of the

alleged U.S. trademark registrations cited by Opposer in paragraph 5 of the Opposition.

22. Applicant affirmatively alleges that the marks listed by Opposer are not sufficiently similar to Applicant's mark as to cause a likelihood of confusion. Opposer's marks consist of a single two-dimensional five-point star, with or without words, and with or without simple accompanying design elements. Applicant's mark is a more complex design consisting of a series of concentric five-point stars lined in a way that creates a three-dimensional effect and encircled by a banner bearing the emblem "LAMA COMFORT TECHNOLOGY." Because of the many substantial differences between Opposer's marks and Applicant's mark, it cannot be said that Applicant's Mark is sufficiently similar as to cause a likelihood of confusion with Opposer's marks. Moreover, the emblem "LAMA COMFORT TECHNOLOGY" is a dominant portion of Applicant's mark and thus prevents any substantial likelihood of confusion of potential consumers.

23. Applicant affirmatively alleges that the marks listed by Opposer are not sufficiently similar to Applicant's mark as to cause dilution of Opposer's mark. Opposer's marks consist of a single two-dimensional five-point star, with or without words, and with or without simple accompanying design elements. Applicant's mark is a more complex design consisting of a series of concentric five-point stars lined in a way that creates a three-dimensional effect and encircled by a banner bearing the emblem "LAMA COMFORT TECHNOLOGY." Because of the many substantial differences between Opposer's marks and

Applicant's mark, it cannot be said that the marks are sufficiently similar as to cause dilution of Opposer's cited marks.

24. Applicant affirmatively alleges that Opposer has acquiesced in the use of a single five-point star incorporated into a design by Boot Royalty Company, L.P. As proof of this allegation, Applicant is the owner of the following U.S. trademark registrations for marks incorporating a five-point star:

The existence of these valid marks, particularly U.S. Trademark Reg. No. 525,522 which claims a first use of December 1923 for "Boots, Shoes [, and Sandals]," demonstrates that Opposer has acquiesced to Applicant's right to use a five-point star incorporated into its design marks. Because of this acquiescence, Opposer cannot now oppose the incorporation of five-point stars into Applicant's Mark.

25. Applicant affirmatively alleges that there are many marks incorporating five-point stars and that Opposer cannot suffer further likelihood of confusion or dilution from Applicant's use of a mark having a series of concentric five-point stars. For example, the following marks are currently registered for goods and services in International Class 25, and such marks incorporate at least one five-point star:

26. Applicant affirmatively alleges that Opposer has acquiesced in third party use of a five-point star incorporated into marks as evidenced by the existence of the valid U.S. trademark registrations listed in the table in paragraph 25. Opposer has not contested or has failed in its contest of these third party marks and thus cannot assert those arguments against Applicant's Mark.
27. Applicant affirmatively alleges that Applicant's goods and services advertised, offered, sold and/or distributed under the mark LAMA COMFORT TECHNOLOGY and Design are distinctly different and distinguishable from those goods and services identified in Opposer's U.S. marks referenced in paragraph 5. Specifically, the following Opposer's marks are not registered for

goods and services related to any kind of footwear, but are registered for items of clothing:

In this case, there cannot be a likelihood of confusion between items registered for “footwear, namely boots” and the above listed marks that are registered for assorted clothing items such as t-shirts, shorts, and tank tops because the identified goods and services are substantially different. Consumers and prospective consumers of Applicant’s goods and services advertised, offered, sold and/or distributed under Applicant’s mark LAMA COMFORT TECHNOLOGY and Design are not likely to be confused, mistaken or deceived that such goods and services in any way emanate from or are in some way sponsored by or affiliated with Opposer’s mark for these goods.

28. Applicant affirmatively alleges that the identified goods of Opposer’s U.S. Trademark Reg. No. 2,466,301 are “exercise books, wirebound books, wirebound hardback books, ballpoint pens, cartridge pens, elasticated binders, erasers, filled pencil cases, pencils, pencil packs, pencil sets” and “book bags and briefcase-style portfolios.” Consumers and prospective consumers of the goods and services advertised, offered, sold and/or distributed under Applicant’s mark LAMA COMFORT TECHNOLOGY and Design are not likely to be confused, mistaken

or deceived that such goods and services in any way emanate from or are in some way sponsored by or affiliated with Opposer's mark for these goods.

29. Applicant affirmatively alleges that the identified goods of Opposer's U.S. Trademark Reg. No. 2,529,040 are "eyewear." Consumers and prospective consumers of the goods and services advertised, offered, sold and/or distributed under Applicant's mark LAMA COMFORT TECHNOLOGY and Design are not likely to be confused, mistaken or deceived that such goods and services in any way emanate from or are in some way sponsored by or affiliated with Opposer's mark for these goods.
30. Applicant affirmatively alleges, for all of Opposer's listed marks, that consumers and prospective consumers of Applicant's goods advertised, offered, sold and/or distributed under Applicant's mark LAMA COMFORT TECHNOLOGY and Design are not likely to be confused, mistaken or deceived that such goods in any way emanate from or are in some way sponsored by or affiliated with Opposer.
31. Applicant affirmatively alleges Opposer will not be damaged by the registration of Applicant's Mark.
32. Applicant affirmatively alleges the goods sold by Applicant under Applicant's Mark and Applicant's use of Applicant's Mark do not dilute any rights Opposer may have in Opposer's marks.
33. Applicant affirmatively alleges that to its knowledge there have been no incidents of actual confusion between Applicant's Mark and Opposer's marks.

In view of the foregoing, Applicant contends that this Opposition is groundless and baseless in fact; that Opposer has not shown that it has been, will be, or is likely to be, damaged


