**NOTICE OF OPPOSITION**

Sweet as Candy Limited, a U. K. limited liability company ("Opposer"), having its principal place of business at 8 Swan Yard, London N1 1SD, United Kingdom, believing that it will be damaged by the registration of the mark "CHEF JAMIE" in International Class 30 on the Principal Register, as shown in the above-referenced application made by Tastebud Entertainment, Inc. ("Applicant"), and hereby opposes the same.

The ground for opposition is likelihood of confusion, as follows:

Opposer owns two (2) registrations for the mark JAMIE OLIVER®: No. 2,866,527, covering goods in International Classes 9 and 21 and services in International Classes 41 and 43; and No. 2,869,105, covering goods in International Class 16 (copies of the Office records concerning these registrations are attached hereto as Exhibits A and B).

Opposer's goods and services are all in the fields of food, cookery, and lifestyle, since the individual named Jamie Oliver is well known throughout the United States not only under his own name but also as "The Naked Chef" (see Exhibit C).

Applicant's application to register the mark "CHEF JAMIE" covers foods in International Class 13, and is therefore also in the fields of food and cookery (a copy of the Office record concerning this application is attached hereto as Exhibit D). Applicant, which is owned by Jamie Gwen Sills, also known as Jamie Gwen, also known as "Chef Jamie" (see Exhibit E), is also in the business of food, cookery, and lifestyle, as can be seen from the copies of pages from the GOOGLE search engine and the website "chefjamie.com" (Exhibit F).


In fact, Jamie Gwen, owner of Applicant, provides goods and services in most, if not all, of the fields covered by Opposer's registrations: books, recipes, television and radio performances, and other entertainment and education services. Moreover, a search for "Chef Jamie" on the GOOGLE search engine shows the top two (and, indeed, seven of the top ten) entries as being for Jamie Oliver (see Exhibit G). This is further evidence of likelihood of confusion.

The fact that the "CHEF JAMIE" application covers food products only does not prevent likelihood of confusion, since food products are (1) closely related to Opposer's goods and services shown on its registrations, and (2) constitute a natural area of expansion for Opposer.

WHEREFORE, Opposer prays that Application Serial No. 78/125,399 will be rejected and that the registration of the mark therein shown for goods therein specified be refused and denied.
