The above-identified opposer believes that she will be damaged by registration of the mark shown in the above-identified application, and hereby opposes the same.


The grounds for opposition are as follows:

1. Kim Bosch van Drakenstein is the owner of one hundred percent shares and President of the Virginia corporation, First Dance Impressions, Inc. (*“the Corporation”*). See *Articles of Incorporation and Certificate of Authority, attached hereto as Exhibit 1.*

2. Prior to the formation of the corporation, Ms. Bosch van Drakenstein had been conducting business under the trade name, First Dance Impressions.

3. Ms. Bosch van Drakenstein developed the name “First Dance Impressions.”

4. Ms. Bosch van Drakenstein owns the Virginia service mark FIRST DANCE IMPRESSIONS and allows the Corporation to use the service mark. *See Virginia Certification of Registration of a Service Mark, attached hereto as Exhibit*

5. First Dance Impressions, Inc. sells dance lessons to individuals and wedding couples in the State of Virginia under the name First Dance Impressions, Inc.

6. Kim Bosch van Drakenstein owns and operates the website www.firstdanceimpressions.com, which generates over fifty percent of the business for the Corporation. *See Home Page and Kim Bosch van Drakenstein Page from www.firstdanceimpressions.com, attached hereto as Exhibit 3.*

7. Kim Bosch van Drakenstein has also registered copyrights for a First Dance Impressions Colored Tri Fold, a First Dance Impressions Deluxe Bi Fold and a First Dance Impressions Video Montage. Ms. Bosch van Drakenstein has also applied for a copyright registration of her website, www.firstdanceimpressions.com. *See Registration of Copyrights and Application for Registration of a Copyright attached hereto as Exhibit 4.*

8. Kim Bosch van Drakenstein and Deborah Joy jointly advertised under the name First Dance Impressions since January 2001.

9. Ms. Bosch van Drakenstein has built a significant reputation as a dance instructor under First Dance Impressions.

10. Ms. Deborah Joy began advertising and otherwise operating as “Wedding Dance Specialists,” on or about September 12, 2004, as an instructor of dance lessons to wedding couples.

11. Providing the applicant, Deborah Joy, with the exclusive right to use the name First Dance Impressions would cause significant damage to Ms. Bosch van Drakenstein and the Corporation because they would be barred from using the name Ms. Bosch van Drakenstein has developed and has been using for three years.

12. Further, Ms. Deborah Joy has applied for a federal service mark “Wedding Dance Specialists” (Serial Number 78402948). Under her application, Ms. Joy describes the class of her service mark as “[d]ance lessons to prepare individuals for weddings or any other special occasion....”

13. Accordingly, your applicant has relinquished her claim to “First Dance Impressions.”

ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED Incorporator hereby forms a stock corporation under the provisions of Chapter 9 of Title 13.1 of the 1950 Code of Virginia (as amended), and to that end sets forth the following:

ARTICLE I.

The name of the corporation is FIRST DANCE IMPRESSIONS, INC.

ARTICLE II.

The purpose of the corporation is to conduct dance instructions services and any other activity allowed by law.

ARTICLE III.

The corporation shall have the authority to issue, in the aggregate, five thousand (5,000) shares of capital stock which shall consist of one class of common stock having no par value.

ARTICLE IV.

The Post Office Address of the initial registered office of the corporation is 4124 Leonard Drive, Fairfax, Virginia 22030. The initial registered office is located in the City of Fairfax, Virginia. The name of the initial registered agent is Bernard J.E. van Gils who is a resident of Virginia, a member of the Virginia State Bar, and whose business address is the same as the address of the initial registered office.

ARTICLE V.


