The Parties, Opposer, EPLAN Software & Service GmbH & Co. KG, and Applicant, Board of Regents, The University of Texas System, have settled this matter, and wish to defer further litigation of this case pursuant to TBMP §605.02 pending the execution of a Settlement Agreement.


