OPPOSITION PROCEEDING

Pursuant to 37 CFR §2.117(a), Applicant, INTELIOUS, INC., hereby moves to suspend proceedings in the above-captioned opposition because there is currently pending another Board proceeding that will have a bearing on this case.

There is currently pending before the Board a cancellation proceeding involving Opposer's INTELLIFINDER mark, Registration No. 1,908,265, upon which this opposition is allegedly based. That action is captioned *Intelius Inc. v. Vantage Technology Holdings LLC*, Cancellation No. 92042948 (the "Cancellation"). The Cancellation is in the testimony period, and the legal issue is whether the Opposer has abandoned the INTELLIFINDER mark.
