

Pursuant to Rule 56 of the Federal Rules of Civil Procedure, Opposer moves the Board for an Order Granting Summary Judgment in its favor on the ground that the mark that it the subject of this Opposition, SMOOTHEMOVE"S, is confusingly similar to Opposer's registered trademark SMOOTH MOVE and registration of applicant's mark is likely to cause confusion in the marketplace.

As grounds for this Motion, Petitioner relies on the Declarations of Drake Sadler and Jay Geller, and the documents attached to Opposer's Notice of Reliance filed contemporaneously with this Motion.

There are no genuine issues of material fact precluding Summary Judgment in favor of Petitioner as follows:

1. Registrant is the owner of United States Trademark Registrations 1,258,223 for the trademark SMOOTH MOVE for herbal teas used as a laxative and 2,520,275 for medicinal herb tea and herb tea used for food purposes. The mark has been continuously used for such goods by Opposer since 1974 on a variety of herbal teas, over-the-counter pharmaceuticals and dietary food supplements. Declaration of Drake Sadler. Registrant has a pending application, SN 78809216 to register the mark SMOOTH MOVE for a variety of over-the-counter pharmaceuticals and dietary supplements. As of the filing of this Motion,



that application has not yet been examined. The application claims a first use date on the goods of 1976.

- Applicant is the owner of United States Trademark Application 78616669
 for the mark SMOOTHMOVE'S for a wide variety of cosmetic products based upon a bona-fide intent to use.
- 3. Opposer's registered mark SMOOTH MOVE and Applicant's applied-for mark SMOOTHMOVE'S are identical in all respects.
- 4. The goods on which Opposer uses its mark SMOOTH MOVE, herb teas, over-the-counter pharmaceuticals and dietary food supplements, and the goods on which Applicant intended to use the mark SMOOTHMOVE'S non-medicated skin care products are closely related. Declaration of Jay H. Geller; Notice of Reliance.
- 5. Opposer's registration is not restricted in any manner as to the goods covered by the registration or the channels of commence covered by the registration. Notice of Reliance; Declaration of Drake Sadler. Applicant's application does not limit in any manner the goods covered by the application or the channels of commerce for such goods. Application on File with the Trademark Office.
- 6. There is a likelihood of confusion in the marketplace between applicant's intended use of the mark SMOOTHMOVE'S on non-medicated skin care products and Opposer's use of the mark SMOOTH MOVE on its over-the-counter pharmaceuticals, herb teas and dietary food supplements.
 - 7. Registration of applicant's mark will cause damage to Opposer.

Wherefore, Opposer prays that the Board grant its Motion and deny registration to Applicant. A memorandum and the Declarations of Drake Sadler and Jay Geller are filed in support of this Motion and the Notice of Reliance is filed contemporaneously with this

Motion.

MEMORANDUM IN SUPPORT

I. FACTUAL BACKGROUND

Opposer Traditional Medicinals, Inc. (TMI) is the owner of United States Trademark Registrations 1,258,223 for the trademark SMOOTH MOVE for herbal teas used as a laxative and 2,520,275 for medicinal herb tea and herb tea used for food purposes. The mark has been continuously used for such goods by Opposer since 1974 on a variety of herbal teas, over-the-counter pharmaceuticals and dietary food supplements. Declaration of Drake Sadler. Registrant has a pending application, SN 78809216, to register the mark SMOOTH MOVE for a variety of over-the-counter pharmaceuticals and dietary supplements claiming a first use date of 1976. As of the filing of this Motion, that application has not yet been examined. Status/title copies of each of these registrations and the pending application are attached to TMI's Notice of Reliance in accordance with TBMP 704.03(b). The declaration of Drake Sadler also establishes TMI's ownership of these registrations.

TMI has used the mark SMOOTH MOVE continuously and exclusively for dietary food supplements, herb teas, medicinal herb teas and over-the-counter pharmaceuticals since 1974 (Decl. Sadler). Attached to the Sadler declaration are copies of SMOOTH product cartons and tea bag overwraps that TMI has used over the past 30+ years. In addition, TMI is expanding its SMOOTH MOVE product line in October, 2006 by adding encapsulated laxatives and dietary supplements (Decl. of Sadler). Also attached to the Sadler deposition are two pages from its website (www.traditionalmedicinals.com) showing the two varieties of SMOOTH MOVE supplements/laxatives/herb teas currently sold by TMI? Representative advertisements for SMOOTH MOVE, also identified by year, alone or with other TMI products, are also attached to the Sadler declaration. These advertisements have appeared in a variety of

magazines and other publications directed to individual consumers. Since 1995, TMI has sold over 1,600,000 cases of SMOOTH MOVE products with net sales to TMI of over \$18,500,000. These sales represent over 9,400,000 individual boxes of SMOOTH MOVE products. When brewed as directed, the total number of cups of SMOOTH MOVE teas that has been sold exceeds 153,000,000 cups! Sales of the product have risen ever year since 1995 and the SMOOTH MOVE products are among the best selling of TMI's products. Through May, 2006 (the first eight months of TMI's fiscal year), the company has sold 136,000 cases of regular SMOOTH MOVE products and 17,500 cases of Chocolate SMOOTH MOVE products. Combined dollar sales for the first eight months of the current fiscal year are over \$2,000,000. The SMOOTH MOVE products are marketed through thousands of grocery, drug, health food and discount retail outlets throughout the United States and on the Internet (Decl. Drake Sadler).

The mark which applicant seeks to register, SMOOTHMOVE'S, is identical in all respects to GEC's registered trademark SMOOTH MOVE. There are numerous examples of trademarks registered for both supplements and cosmetics. Attached to TMI's Notice of Reliance are electronic copies of the following recent registrations from the official electronic database of the USPTO from the website (www.uspto.gov) that cover dietary supplements and over-the-counter drugs on the one hand, and cosmetics on the other: Cameo design, RN 31000026; HEALING ANTHROPLOGY, RN 2940154; BeeTanicals, RN 3019825; DIVINE ESSENCE, RN 2917229; MAHARISHI AYURVEDA, RN 27997932; ADVANCED DEFENSE, RN 3056073; XHUMAN, RN 2701617; DR. 3016174; SHANKARA, RN 2863532; PLANET MOTHERHOOD, RN 2735270; MOUNTAIN ROSE HERBS, RN 3019383; TROPICAL TRADITIONS, RN 2907903; NU-MED Design, RN 2873276; WORKING WITH NATURE TO MAKE A DIFFERENT, RN 2800846; FIRMAGEN, RN 3040759; ROEX R Design, RN 2946081; NUTRAFINA, RN 3030380; DR. SEARS ZONE LABS, RN 3074327; UDDERLY COLOSTRAL, RN 2760603; FORMULARY, RN 2926599; UNICITY, RN 2995456; NATURES ULTIMATE Design, RN 3045460; LIFE-FLO, RN 27513790 and RICE THERAPY, RN 3083113. These third party registrations demonstrate conclusively that supplements and cosmetics are closely related goods and that there are a plethora of entities that market both supplements and cosmetics under the identical trademark.

As of the date of filing this Motion for Summary Judgment, Opposer is unaware of actual use of the mark SMOOTHMOVE'S by Applicant.

TMI believes that a registration of the mark SMOOTHMOVE'S by applicant will damage it by likely causing confusion in the marketplace by virtue of the fact that dietary supplements, over-the-counter pharmaceuticals and skin care products are all sold in the same channels of commerce to the same consumers. TMI believes that consumers encountering Applicant's goods in the marketplace, because those goods could be sold in any type of retail or wholesale marketing environment, could believe that these products emanate from TMI, either directly or under license, because of TMI's longstanding use of the name SMOOTH MOVE (Sadler Decl.).

ARGUMENT

The law applicable to a determination of likelihood of confusion is clear. It is well settled that the relevant test is *likelihood of confusion*, not actual confusion. It is unnecessary to show actual confusion to establish likelihood of confusion. *Weiss Associates Inc.*, v. HRL Associates Inc., 902 F.2d 1546, 1549, 14 USPQ2d 1840, 1842-43 (Fed. Cir. 1990), and cases cited therein.

If the marks of the respective parties are identical, as they are here, the relationship between the goods or services need not be as close to support a finding of likelihood of confusion as would be required in a case where there are differences

between the marks. Amcor, Inc. v. Amcor Industries, Inc., 210 USPQ 70, 78 (TTAB 1981). The goods or services do not have to be identical or even competitive in order to determine that there is a likelihood of confusion. The inquiry is whether the goods are related, not identical. The issue is not whether the goods will be confused with each other, but rather whether the public will be confused about their source. See Safety-Kleen Corp. v. Dresser Indus., Inc., 518 F.2d 1399, 1404, 186 USPQ 476, 480 (C.C.P.A. 1975). It is sufficient that the goods or services of the applicant and the registrant are so related that the circumstances surrounding their marketing are such that they are likely to be encountered by the same persons under circumstances that would give rise to the mistaken belief that they originate from the same source. See, e.g., On-line Careline Inc. v. America Online Inc., 229 F.3d 1080, 56 USPQ2d 1471 (Fed. Cir. 2000); In re Martin's Famous Pastry Shoppe, Inc., 748 F.2d 1565, 223 USPQ 1289 (Fed. Cir. 1984); In re Corning Glass Works, 229 USPQ 65 (TTAB 1985); and In re Jeep Corp., 222 USPQ 333 (TTAB 1984.

The nature and scope of a party's goods or services must be determined on the basis of the goods or services recited in the application or registration. See, e.g., Hewlett-Packard Co. v. Packard Press Inc., 281 F.3d 1261, 62 USPQ2d 1001 (Fed. Cir. 2002); In re Shell Oil Co., 992 F.2d 1204, 26 USPQ2d 1687, 1690 n. 4 (Fed. Cir. 1993); J & J Snack Foods Corp. v. McDonald's Corp., 932 F.2d 1460, 18 USPQ2d 1889 (Fed. Cir. 1991); Octocom Systems Inc. v. Houston Computer Services Inc., 918 F.2d 937, 16 USPQ2d 1783 (Fed. Cir. 1990); Canadian Imperial Bank of Commerce, N.A. v. Wells Fargo Bank, 811 F.2d 1490, 1 USPQ2d 1813 (Fed. Cir. 1987); Paula Payne Products Co. v. Johnson Publishing Co., 473 F.2d 901, 177 USPQ 76 (C.C.P.A. 1973). Here, the

goods recited in Opposer's registration are laxatives and herbal teas and on product packaging as laxatives, medicinal herb teas and dietary food supplements. All of these goods have been sold by TMI since 1974.

If the cited registration describes goods or services broadly, and there is no limitation as to the nature, type, channels of trade or class of purchasers, it is presumed that the registration encompasses all goods or services of the type described, that they move in all normal channels of trade, and that they are available to all classes of purchasers. Here, neither Opposer's registration nor applicant's application is limited in any way – as to goods described, channels of commerce and/or class of purchasers. Therefore, if the cited registration has a broad identification of goods or services, an applicant does not avoid likelihood of confusion merely by more narrowly identifying its related goods. *See, e.g., In re Linkvest S.A.,* 24 USPQ2d 1716 (TTAB 1992); *In re Diet Center Inc.,* 4 USPQ2d 1975 (TTAB 1987; *In re Uncle Sam Chemical Co., Inc.,* 229 USPQ 233 (TTAB 1986).

Evidence of relatedness might include news articles and/or evidence from computer databases showing that the relevant goods or services are used together or used by the same purchasers: advertisements showing that the relevant goods or services are advertised together or sold by the same manufacturer or dealer; or copies of prior use-based registrations of the same mark for both applicant's goods and services and the goods and services listed in the cited registration. Third-party registrations that cover a number of different goods or services have probative value to the extent that they may serve to suggest that goods or services are of a type that may emanate from a single

source (TMEP 1207.01(d)(iii)). Attached to Opposer's Notice of Reliance (Exhibit B) are copies of recently and long-standing issued registrations that cover goods in both Classes 3 and 5 from the official USPTO website. Attached to Geller declaration are documents downloaded from the Internet that show databases and advertisements of companies that currently sell both supplements and cosmetics under the same mark).

Finally, if there is any doubt as to whether there is a likelihood of confusion, that doubt must be resolved in favor of the prior registrant. *In re Shell Oil Co.*, 992 F.2d 1204, 26 USPQ2d 1687 (Fed. Cir. 1993); *In re Hyper Shoppes (Ohio), Inc.* 837 F.2d 463, 6 USPQ2d 1025 (Fed. Cir. 1988).

CONCLUSION

Here, because the marks are identical, the goods are closely related, there are numerous third party registrations that cover TMI's goods and Applicant's goods, the use by third parties of the same mark on supplements and skin care preparations and cosmetics, the length of use of the mark SMOOTH MOVE by TMI (over 30 years) and the substantial sales of TMI's SMOOTH MOVE products over the past ten years, there is no genuine issue of material fact precluding a finding that there is a likelihood of confusion in the marketplace between TMI's use of its registered mark on its over-the-counter pharmaceuticals and dietary supplements and Applicant's use of the mark SMOOTHMOVE'S on skin care preparations. Since there is no genuine issue of material fact on this issue, as a matter of law, there is a likelihood of confusion between TMI's use of SMOOTH MOVE and Applicant's intended use of SMOOTHMOVE'S and

registration to Applicant should be refused. TMI respectfully requests that the TTAB grant is Motion for Summary Judgment.

DECLARATION OF DRAKE SADLER

Drake Sadler, under penalty of perjury of the laws of the United States, sweare and states as follows:

- 1. I am the CEO of Traditional Medicinals, Inc (TMI). If called as a witness in this matter, I would testify to the following facts of my own personal knowledge.
- 2. I was one of the founders of TMI in 1974. One of the first products that TMI marketed was SMOOTH MOVE herb tea and herbal laxative over-the-counter pharmaceutical. Continuously since 1974, TMI has marketed SMOOTH as an herb tea and herbal laxative over-the-counter pharmaceutical. When the Food, Drug and Cosmetic Act was amended in 1994 to expand the legal definition of dietary supplement, TMI changed the labeling of the SMOOTH MOVE product to position is as a dietary supplement as well as herb tea and herbal laxative over-the-counter pharmaceutical. SMOOTH MOVE has consistently, since its inception, been one of the best selling TMI products. TMI owns United States Trademark Registrations 1258223 and 2520275 and pending application serial number 78809216 for the trademark SMOOTH MOVE.
- 3. Attached as Exhibit A to my declaration are representative samples of product packaging and labeling used by TMI for its SMOOTH MOVE products over the years (1974, 1975, 1984, 1989, 2000, 2002, 2005 and 2006. Each page has the year of use of the packaging. These samples consist of product cartons. TMI is expanding its SMOOTH MOVE product line in October, 2006 by adding encapsulated laxatives and dietary supplements.

- 4. Attached as Exhibit B two pages from TMI's website


 (www.traditionalmedicinals.com) showing the current packaging and product
 information for the two varieties of SMOOTH MOVE supplements/laxatives (regular and chocolate flavor) currently sold by TMI.

TMI believes that consumers encountering Applicant's goods in the marketplace, because those goods could be sold in any type of retail or wholesale marketing environment, could believe that these products emanate from TMI, either directly or under license, because of TMI's longstanding and widespread use of the trademark SMOOTH MOVE.
