APPLICANT'S RESPONSE TO COMMUNICATION

Applicant, The Gillette Company ("Applicant") hereby responds to the communication issued on July 17, 2013, by Clara Vela, Paralegal Specialist, in connection with the above-referenced opposition.

A final decision has been reached by the Italian Court of Appeals in favor of The Gillette Company. Following that decision, Kelemata S.P.A. ("Opposer") filed an appeal to the Supreme Court.

Our Italian counsel estimates that the Supreme Court Appeal proceedings may take three to five years from the initial appeal which is two to four years from now.

Accordingly, Applicant requests that the opposition proceeding remain suspended pending the outcome of the civil proceeding between the parties.
