Blue Marlin Corp. (“Opposer”), a California Corporation having its principal place of business at 299 Kansas Street, San Francisco, California 94103, believes that it will be damaged by registration of the mark shown in application Serial No. 78/567,859 and hereby opposes the same.

As grounds for the opposition, it is alleged as follows:

1. Opposer designs, markets, and distributes premium quality vintage sportswear and head wear under the BLUE MARLIN® brand. Opposer has used BLUE MARLIN® trademarks

on a variety of clothing and bags since at least 1994 and the BLUE MARLIN FIVE STAR VINTAGE® trademark since at least 2001. Opposer is well known for its vintage sports line, which is found in approximately five hundred high-end specialty stores and department stores nationwide, including Bloomingdale's, Macy's, Marshall Field's, Lord & Taylor, Nordstrom, and Virgin Superstores. International sales and online sales at www.bluemarlincorp.com also account for a significant portion of Opposer's business.

2. Opposer is the owner of four U.S. Trademark Registrations in International Class 25 for marks incorporating its BLUE MARLIN® trademark for vintage style apparel, including BLUE MARLIN®, BLUE MARLIN® & Circle Design, and BLUE MARLIN FIVE STAR VINTAGE®.

3. On June 6, 2000, Opposer obtained a registration for the mark BLUE MARLIN, Registration No. 2,354,501, on the Principal Register of the United States Patent and Trademark Office for use in International Class 25 in connection with "vintage style sports clothing, namely hats, caps, dresses, jackets, jeans, jogging suits, warm-up suits, loungewear, nightshirts, sweaters, vests, halter tops, shirts, undershirts, t-shirts, sweatshirts, shorts, gym shorts, sweat shorts, sweat pants, [and] trousers." Opposer owns the mark covered by Registration No. 2,354,501, the registration, and the goodwill connected with and symbolized by the mark. A true and correct copy of a printout from the website of the United States Patent and Trademark Office setting forth the details of Registration No. 2,354,501 is attached hereto as **Exhibit A**.

4. On November 28, 2000, Opposer obtained a registration for BLUE MARLIN & Blue Circle Design, Registration No. 2,408,486, on the Principal Register of the United States Patent and Trademark Office for use in International Class 25 in connection with "vintage style apparel, namely, hats, caps, dresses, jackets, jeans, jogging suits, warm-up suits, lounge wear, nightshirts, sweaters, vests, halter tops, shirts, undershirts, t-shirts, sweatshirts, shorts, gym shorts, sweat shorts, sweat pants, [and] trousers." Opposer owns the mark covered by Registration No. 2,408,486, the registration, and the goodwill connected with and symbolized by the mark. A true

and correct copy of a printout from the website of the United States Patent and Trademark Office setting forth the details of Registration No. 2,408,486 is attached hereto as **Exhibit B**.

5. On January 7, 2003, Opposer obtained a registration of the mark BLUE MARLIN & Circle Design, Registration No. 2,671,863, on the Principal Register of the United States Patent and Trademark Office for use in International Class 25 in connection with “vintage style apparel, namely – hats, caps, dresses, jackets, jeans, jogging suits, warm-up suits, loungewear, nightshirts, sweaters, vests, halter tops, undershirts, t-shirts, sweatshirts, shorts, gym shorts, sweat shorts, trousers, khakis, and woven shirts.” Opposer owns the mark covered by Registration No. 2,671,863, the registration, which is valid, subsisting, uncancelled and unrevoked, and the goodwill connected with and symbolized by the mark. A true and correct copy of a printout from the website of the United States Patent and Trademark Office setting forth the details of Registration No. 2,671,863 is attached hereto as **Exhibit C**.

6. On October 22, 2002, Opposer obtained a registration of the mark BLUE MARLIN FIVE STAR VINTAGE, Registration No. 2,639,177, on the Principal Register of the United States Patent and Trademark Office for use in International Class 25 in connection with “vintage style apparel, namely – hats, caps, dresses, jackets, jeans, jogging suits, warm-up suits, loungewear, nightshirts, sweaters, vests, halter tops, undershirts, t-shirts, sweatshirts, shorts, gym shorts, sweat shorts, trousers, khakis, and woven shirts.” Opposer owns the mark covered by Registration No. 2,639,177, the registration, which is valid, subsisting, uncancelled and unrevoked, and the goodwill connected with and symbolized by the mark. A true and correct copy of a printout from the website of the United States Patent and Trademark Office setting forth the details of Registration No. 2,639,177 is attached hereto as **Exhibit D**.

7. Panama Jack International, Inc., Inc. is the owner of Application Serial No. 78/567,859 for BLUE MARLIN BY PANAMA JACK BRANDS in International Class 14 for “jewelry, rings, anklets, bracelets, necklaces, earrings, pendants and ornamental pins; body piercing rings, charms, clocks; jewelry chains; watches.” This application was filed on February

15, 2005 based upon an alleged intent to use the mark in commerce, and published for opposition in the Official Gazette of October 18, 2005.

8. The registrations for BLUE MARLIN®, BLUE MARLIN® & Circle Design, and BLUE MARLIN FIVE STAR VINTAGE® (hereinafter collectively referred to as “Opposer’s BLUE MARLIN® Trademarks”) were all issued prior to the February 15, 2005 filing date of Application Serial No. 78/567,859.

9. The BLUE MARLIN portion of the BLUE MARLIN BY PANAMA JACK mark is identical in sight and sound to the BLUE MARLIN portions of Opposer’s BLUE MARLIN® Trademarks.

10. Applicant’s BLUE MARLIN BY PANAMA JACK BRANDS designation is likely to lead consumers to falsely believe that Opposer has collaborated with Applicant—Panama Jack, Inc.—to design something to be marketed under its BLUE MARLIN label, and that any goods Applicant sells using this designation are approved and endorsed by Opposer Blue Marlin Corp. For example, when Polo Fashions, Inc. uses its trademark POLO BY RALPH LAUREN® (U.S. Registration No. 1,057,453) customers understand that Ralph Lauren has designed something which will be sold in his POLO line of clothing and accessories. Similarly, Stella McCartney would not be able to register the designation ADIDAS BY STELLA MCCARTNEY without first entering into an agreement with the owner of the ADIDAS® trademark. “Adidas by Stella McCartney” indicates to customers that Stella McCartney has designed a line of women’s sportswear in collaboration with adidas, which will be sold by adidas. *See* adidas’ press release of September 8, 2004, *available at* http://www.press.adidas.com/en/desktopdefault.aspx/tabid-16/94_read-441/ and attached hereto as **Exhibit E** (“adidas and Stella McCartney announced a long-term partnership today...presenting the adidas by Stella McCartney sport performance collection.”)

11. Applicant has alleged that it intends to use the BLUE MARLIN BY PANAMA JACK BRANDS on various accessories, including jewelry and watches, which are complimentary to the goods sold by Opposer. It is common for fashion companies offering clothing lines to

register and use their brand names in connection with jewelry and watches in International Class 14. For example, Polo and Tommy Hilfiger both sell jewelry and watches using brand names also used in connection with their clothing lines. PRL USA Holdings, Inc. is the owner of POLO both for its clothing, including “jackets, blazers, dress shirts, sweatshirts, sweaters, and hats” in International Class 25 (U.S. Registration No. 1,363,459) and POLO RALPH LAUREN for watches and clocks. See U.S. Registration No. 1,955,248 attached hereto as **Exhibit F**. It is also the owner of an application for POLO for jewelry and watches. See U.S. Application Serial No. 78/528,483 attached hereto as **Exhibit G**. Tommy Hilfiger Licensing, Inc. is the owner of TOMMY HILFIGER both for “its “full line of apparel, footwear and headwear” in International Class 25 (U.S. Registration No. 2,575,670) and for jewelry. See U.S. Registration Nos. 2,162,940 attached hereto as **Exhibit H**. It is also the owner of an application for watches and jewelry. See U.S. Application Serial No. 78/520,904 attached hereto as **Exhibit I**. The fact that these products are complementary Opposer’s goods is likely to cause customers to believe they are from the same source.

12. In view of the fact that Applicant’s BLUE MARLIN BY PANAMA JACK mark incorporates Opposer’s BLUE MARLIN® Trademarks wholesale; that Applicant’s BLUE MARLIN BY PANAMA JACK mark falsely creates the impression that Opposer is the source of Applicant’s goods; that Opposer’s BLUE MARLIN® Trademarks are used on sportswear distributed at stores both nationally and internationally; and that goods sold under Opposer’s BLUE MARLIN® Trademarks are complementary to those Applicant allegedly intends to sell, Applicant’s BLUE MARLIN BY PANAMA JACK mark is likely to cause confusion, or to cause mistake, or to deceive. Opposer thereby will be injured by Applicant’s BLUE MARLIN BY PANAMA JACK mark.

Filing Fee: The Patent & Trademark Office is authorized to charge \$300.00 for the Notice of Opposition to Morrison & Foerster’s **Deposit Account 03-1952 (Reference No. 52395-24003.33)**.

WHEREFORE, Opposer prays that application Serial No. 78/567,859 be rejected, that no registration be issued thereon to application, and that this opposition be sustained in favor of Opposer.


