Opposer, PPC Marketing, Ltd. ("PPC"), files this Stipulated Motion to Extend Deadline to Respond to Applicant's Motions for Summary Judgment:

1. Applicant, Michael Foods, Inc ("MFI"), filed its Motions for Summary Judgment with the Board on November 3, 2006 for the above-referenced proceedings and served PPC with its Motions on the same day via first-class mail. Therefore, PPC's deadline to respond to MFI's summary judgment motions is December 8, 2006.
2. On November 7, 2006, the Board, on its own initiative, ordered consolidation of Opposition Nos. 91171425 and 91171426.
3. The parties are currently engaged in settlement discussions and require additional time to explore settlement options.
4. The parties have stipulated to a 60-day extension of PPC's deadline to respond to MFI's motions for summary judgment until February 6, 2007.

5. 37 C.F.R. § 2.127(e)(1) provides that the time to respond to a motion for summary judgment may be extended upon stipulation of the parties approved by the Board, or upon motion granted by the Board.

WHEREFORE, Opposer respectfully requests that Opposer's Stipulated Motion to Extend Deadline to Respond to Applicant's Motions for Summary Judgment be approved by the Board.


