**AMENDED NOTICE OF OPPOSITION**

RE/MAX International, Inc., a Colorado corporation, located and doing business at 8390 East Crescent Parkway, Suite 600, Greenwood Village, Colorado 80111 (hereinafter "Opposer") believes that it will be damaged by the registration of LENDMAX, a mark sought to be registered through U.S. Service Mark Application Serial No. 78525633, filed on December 2, 2004, by Tipmuny C. Powers, an individual, (hereinafter "Applicant"), and Opposer hereby opposes the same. Opposer files this Amended Notice of Opposition as a matter of course, pursuant to 37 CFR § 2.107, Fed.R.Civ.P. 15(a), and TBMP 507.02, as the Applicant has not yet served a responsive pleading.

The grounds for opposition are as follows:

1. Opposer provides real estate brokerage services throughout the United States and in numerous foreign countries through a network of sub-franchisors, franchisees, and affiliated sales agents who are authorized to use Opposer's registered service marks in connection with real estate brokerage services ("Opposer's Affiliates").

2. Opposer, since at least as early as 1973, has provided real estate brokerage services in interstate commerce through brokerage offices owned and operated by it and, since at least as early as 1977, through Opposer's Affiliates, all in connection with its distinctive registered service marks, "REMAX" and "RE/MAX".

3. Opposer owns the following United States Trademark Registrations, among others:

Copies of the registration certificates for these registrations are attached as Exhibit A.

4. Registrations numbers 1,139,014; 1,339,510; 2,054,698; 2,106,387; and 2,119,607 are incontestable, pursuant to 15 U.S.C. Section 1065. Opposer's common law and federal registration rights in and to the RE/MAX and REMAX marks are collectively referred to as the "RE/MAX Marks."

5. Opposer and Opposer's Affiliates use the RE/MAX Marks on a variety of advertising media including yard signs, business cards, newspapers and other print media, directional signs, open house signs, hot and cold air balloons, television commercials, Internet web sites, billboards, displays at sporting events, bus stop benches, transit buses, moving vans, banners, brochures, coffee mugs and other advertising and promotional items.

6. Since at least as early as 1974, Opposer and Opposer's Affiliates, which are over 100,000 in number, have invested over six billion dollars to develop, promote and maintain the RE/MAX Marks in the United States and worldwide. Opposer's Affiliates have used the RE/MAX Marks in connection with representing either the buyer or the seller over 20 million times in real estate sale transactions in the United States and worldwide, resulting in over two and a half trillion dollars in sales volume from as early as 1973 to present date.

7. As a result of substantial sales and extensive advertising and promotion, the RE/MAX Marks have become widely and favorably known as identifying real estate brokerage services originating from, sponsored by or associated with Opposer. Indeed, the RE/MAX Marks are famous. The public has come to associate the RE/MAX Marks as a source of high quality real estate brokerage services.

8. Opposer and Opposer's Affiliates have also used the RE/MAX Marks in connection with other services offered to real estate owners in their capacities as homeowners or real estate owners, including homeowner's insurance. Opposer and/or Opposer's Affiliates also frequently refer owners and purchasers of real property to other providers of such ancillary services, including through Opposer's "Approved Supplier" program, and through referrals by individual RE/MAX sales agents for services related to the home buying process, such as inspections, mortgage and home equity lending services, insurance, locksmith services, title services, home

construction, repair, and renovation contractor services. As a result of such provision and referrals for such ancillary services, and as a result of the fame of the RE/MAX Marks for real estate services, the public is likely to associate with Opposer the use of marks similar to the RE/MAX Marks in connection with services ancillary to the home buying process.

9. Applicant filed U.S. Trademark Application Serial No. 78525633 on December 2, 2004, seeking to register LENDMAX, as shown below ("Applicant's Mark"). By that application, as amended, Applicant seeks to register Applicant's Mark as a trademark in connection with "Real Estate Brokerage" in International Class 36, services identical to the services provided Opponent's Affiliates and covered by several of Opponent's registrations for the RE/MAX Mark.



10. Applicant's Mark was published in the Official Gazette for opposition on June 13, 2006. On June 15, 2005, Opponent timely requested, and was granted, a 30-day extension of time in which to oppose the registration of Applicant's Mark, to and including August 12, 2006. August 12, 2006 fell on a Saturday, and this Notice of Opposition is being filed on the next succeeding day that is not a Saturday, Sunday, or a Federal holiday, pursuant to 37 C.F.R. 2.196. Therefore, this Notice of Opposition is timely filed.

11. Applicant's Mark, when used in connection with the goods identified in application serial No. 78525633 is likely to cause confusion, or to cause mistake, or to deceive consumers as to the source of Applicant's services or as to an affiliation, connection or association between

Opposer and Applicant, or as to the origin, sponsorship, or approval of Applicant's, services or other commercial activities.

12. Opposer's RE/MAX name and the RE/MAX Marks are of sufficient fame and reputation among consumers that, when Applicant's Mark is used in connection with the services set forth in the application, a false connection with Opposer will be presumed by consumers.

13. Opposer has not in any way authorized Applicant's use of LENDMAX for the services set forth in Application Serial No. 78525633.

14. In the application at issue, Applicant originally offered as a specimen of his use of the mark a screen shot from The Internet Archive (archive.org), a third-party web site that archives web pages as they appeared in the past. The URL for the web page offered suggests that the web page was not a screen shot of lendmax.com, but actually is a screen shot of the web site <http://www.lendmax.com>, as it appeared on April 4, 2001. The Office rejected the specimen on the basis that the specimen did not show use of the mark in connection with the services identified in the application, and the Applicant later amended the application to an intent-to-use basis pursuant to section 1(b) of the Lanham Act.

15. However, other archived pages from lendmax.com on The Internet Archive suggest that by November 28, 2001 Applicant had ceased causing even the minimal content shown in the specimen on the web site lendmax.com and was offering the domain for sale. On information and belief, Applicant continued offering the domain for sale, and/or using it only to show pages of paid advertising links through the present day. Printouts from The Internet Archive showing the site as it appeared on April 4, 2001, November 28, 2001, January 19, 2002, July 11, 2003, November 26, 2003, and February 7, 2004 are attached hereto as Exhibit B. A printout of

lendmax.com as it appears today, August 17, 2006, showing that the domain continues to be offered for sale, is attached as Exhibit C.

16. On information and belief, the evidence of Applicant's use of lendmax.com demonstrates that Applicant has abandoned Applicant's Mark or, in the alternative, that Applicant committed fraud on the USPTO because he knew when he submitted the lendmax.com specimen with the original application that the specimen was not current and did not demonstrate Applicant's use of the mark, and/or because Applicant does not currently have a bona fide intent to use the mark pursuant to section 1(b) of the Lanham Act.

17. The registration of Applicant's Mark on the Principal Register would be inconsistent with Opposer's rights under the aforementioned registrations, the common law and the Trademark Act, and would be damaging to Opposer.

WHEREFORE, Opposer RE/MAX INTERNATIONAL, INC. believes that it would be damaged by registration of Applicant's Mark and respectfully prays that U.S. Service Mark Application Serial No. 78525633 for LENDMAX be rejected, that no registration be issued thereon, and that this opposition be sustained in favor of Opposer.
