Applicant's consented motion (filed June 11, 2008) to reopen applicant's testimony period and reset remaining trial dates is granted. Trademark Rule 2.127(a).

In view thereof, testimony periods are reset as follows:

DISCOVERY TO CLOSE: **CLOSED**

Thirty-day testimony period for party in position of plaintiff to close: **CLOSED**

Thirty-day testimony period for party in position of defendant to close: **July 11, 2008**

Fifteen-day rebuttal testimony period for plaintiff to close: **August 25, 2008**

In each instance, a copy of the transcript of testimony together with copies of documentary exhibits,

must be served on the adverse party within thirty days after completion of the taking of testimony. Trademark Rule 2.125.

Briefs shall be filed in accordance with Trademark Rule 2.128(a) and (b). An oral hearing will be set only upon request filed as provided by Trademark Rule 2.129.

**NEWS FROM THE TTAB:**

The USPTO published a notice of final rulemaking in the Federal Register on August 1, 2007, at 72 F.R. 42242. By this notice, various rules governing Trademark Trial and Appeal Board inter partes proceedings are amended. Certain amendments have an effective date of August 31, 2007, while most have an effective date of November 1, 2007. By one rule change effective August 31, 2007, the Board's standard protective order is made applicable to all TTAB inter partes cases, whether already pending or commenced on or after that date. Further, as explained in the final rule, parties are free to agree to a substitute protective order or to supplement or amend the standard order even after August 31, 2007, subject to Board approval.
