DEFENDANT’S REPLY AND OPPOSITON TO PLAINTIFF’S
REVOCATION OF PREVIOUS POWER OF ATTORNEY
APPOINTMENT OF NEW ATTORNEY
AND CHANGE OF CORRESPONDENCE ADDRESS

Now comes, Michael Dalton, Defendant – Applicant, and hereby presents his reply to Opposer’s response to Defendant’s Opposition to Plaintiff’s Revocation of Previous Power of Attorney, Appointment of New Attorney and Change of Correspondence Address.

The Board should consider the facts in this matter:

- 1.) Joseph Juliano is not an attorney of record in this matter.
- 2.) Joseph Juliano is not an identified domestic representative of Opposer.¹
- 3.) The Opposer, Honda Motor Company, Ltd is a foreign, alien, entity organized under the laws of Japan.²
- 4.) Joseph Juliano self identified as a representative of Honda Patents & Technologies N.A. LLC.³

- 5.) Honda Patents & Technologies N.A. LLC. is not an identified organizational structure of Honda Motor Company, Ltd.⁴
- 6.) Honda Patents & Technologies N.A. LLC is not a party to this proceeding.⁵ In fact, no domestic organization has opposed defendant's application and therefore waived⁶.
- 7.) Honda Motor Company, Ltd articles of incorporation clearly state who may represent the foreign entity.⁷
- 8.) Joseph Juliano is not an identified representative director.⁸
- 9.) The filing is void of any / all attorney registration numbers.

Since the defendant has respect for the concept of due process, no further remarks could respectfully address Ms. DuCharme's arrogant rants in support of the Opposer, acting as intermeddler, and their meritless opposition wasting the time of the Trademark Office.

Therefore:

The, 07/07/2010 filed revocation power of attorney, appointment of new attorney, and change of correspondence address is unsigned by the Opposer, is not a party to this proceeding, or someone with legal authority to bind the Opposer⁹.

Juliano is without authority to bind the Opposer under the corporate laws of Honda Motor Company, Ltd articles of incorporation, with sole jurisdiction in Japan. Opposer


and Opposer's alleged attorneys knew, or should have known, that Juliano is neither an authorized representative director nor an authorized domestic representative by the Opposer.¹⁰

The Opposer has not designated a domestic representative.¹¹

There has been no withdrawal of attorneys of record for Opposer, Honda Motor Company, Ltd.

As such, the board should deny the revocation of power of attorney, appointment of new attorney or change of correspondence address and take whatever steps it deems necessary to prevent the Opposer, and those claiming to represent the Opposer, from committing misrepresentations and/or fraud upon the Board in the future¹².


