NOTICE OF OPPOSITION

Dayhoff, LLC, a limited liability company organized under the laws of the State of Florida and having a principal place of business at 1200 Walnut Hill Lane, Suite 1700, Irving, Texas 75038, and Grupo Bimbo, S.A. de C.V., a corporation duly organized and existing under the laws of the Country of Mexico, with principal offices at Prolongacion Paseo de la Reforma No. 1000, Col. Peña Blanca Santa Fe, Delagacion Alvaro Obregon, Mexico City, Mexico 01210, D.F., believe that they will be damaged by registration of United States Trademark Application

Serial No. 78/686,043 filed on August 4, 2005 (the "Application") by Imagine Global LLC ("Applicant") and hereby oppose the same. The grounds for opposition are as follows:

1. Dayhoff, LLC is an affiliate of Grupo Bimbo, S.A. de C.V. Dayhoff, LLC manufactures and sells products in the United States and distributes and sells products imported into the United States. Dayhoff, LLC manufactures and distributes products in the United States of America under the marks JUICEE GUMMEE, JUICEE GUMMEE & Design, and JUICEE GUMMEE POWERED BY REAL JUICE & Design. Hereinafter, Grupo Bimbo, S.A. de C.V. and its U.S. subsidiary Dayhoff, LLC will be collectively referred to as "Opposer."

2. Opposer is now and has been engaged in the production and sale of candy and snack foods for many years.

3. At least as early as April 30, 1997, Opposer adopted and began using in United States commerce regulated by Congress, and continues to use, the mark JUICEE GUMMEE for snack foods, gelatin candy commonly known as "gummy candy" (hereinafter, the "products").

4. On December 12, 2001, Opposer filed U.S. Trademark Application Serial No. 78/097,977 for its JUICEE GUMMEE & Design mark for use in connection with its products "gummy candy," which application matured to U.S. Registration No. 2,675,139 on January 14, 2003; such Registration is valid and subsisting. See **Exhibit A** attached hereto for a copy of the Certificate of Registration for Registration No. 2,675,139 and a printout from the Trademark Application and Registration Retrieval System ("TARR") evidencing the current status of Registration No. 2,675,139.

5. On January 25, 2005, Opposer filed U.S. Trademark Application Serial No. 78/553,456 for its JUICEE GUMMEE mark for use in connection with its products, which application matured to U.S. Registration No. 3,128,852 on August 15, 2006; such Registration is valid and subsisting. See **Exhibit B** attached hereto for a copy of the Certificate of Registration for Registration No. 3,128,852 and a printout from the Trademark Application and Registration Retrieval System ("TARR") evidencing the current status of Registration No. 3,128,852.

6. Opposer hereby gives notice that in addition to rights granted to Opposer pursuant to U.S. Trademark Registration Nos. 2,675,139 and 3,128,852, Opposer will also rely on common law rights acquired by its long time usage of the mark JUICEE GUMMEE.

7. Hereinafter, Opposer's JUICEE GUMMEE marks that are the subject of U.S. Trademark Registration Nos. 2,675,139 and 3,128,852 and its common law rights in the JUICEE GUMMEE mark will be collectively referred to as the "JUICEE GUMMEE marks."

8. Since at least as early as 1997, Opposer has offered and advertised its goods in connection with the JUICEE GUMMEE marks in interstate commerce.

9. On August 4, 2005, Applicant filed U.S. Application Serial No. 78/686,043 for the mark YUMMY JUICY & Design for use in connection with "crystal sugar pieces confectionery; fruit jellies confectionery" in Class 30 and claimed first use of the mark in commerce as early as July 15, 2005 in association with the stated goods. See **Exhibit C** for printouts from TESS and TARR evidencing the Application and current status of same. Said Application was published for opposition on September 26, 2006; a copy of the publication is attached hereto as **Exhibit D**.

10. Applicant's representatives Carlos Marroquin and Arash Kousheshian were formerly employed with Dayhoff LLC and, upon information and belief, both were aware that JUICEE GUMMEE was a trademark used on one of Dayhoff LLC's best selling products.

11. Upon information and belief, Applicant did not use YUMMY JUICY & Design for crystal sugar pieces confectionery and fruit jellies confectionery and related goods before Opposer adopted and began using its JUICEE GUMMEE marks.

12. Upon information and belief, Applicant intentionally adopted the mark YUMMY JUICY to trade upon the goodwill of Dayhoff LLC's JUICEE GUMMEE marks. Upon information and belief, Applicant intends to mislead the public into believing it is associated with or endorsed by the Opposer in order to gain unfair advantage in the marketplace.

13. Applicant's mark, YUMMY JUICY & Design, if used in connection with the goods described in the Application, is confusingly similar to Opposer's JUICEE GUMMEE marks, will be used on goods closely related to those of Opposer, which goods will move through trade channels similar or identical to the trade channels through which Opposer's goods sold under the JUICEE GUMMEE marks move, and will be likely to be encountered by many of the same consumers who are purchasers or prospective purchasers of Opposer's JUICEE GUMMEE goods.

14. Applicant's YUMMY JUICY & Design trademark comprises a mark which so resembles Opposer's JUICEE GUMMEE marks previously used in the United States and not abandoned as to be likely, when used on or in connection with the goods of Applicant, to cause confusion or to cause mistake or to deceive as to the affiliation, connection, association, origin,

sponsorship, endorsement, or approval of Applicant's goods by Opposer, to the irreparable damage of Opposer.

15. Any dissatisfaction with Applicant's goods offered under the YUMMY JUICY & Design mark will necessarily reflect on and injure the reputation and good will associated with Opposer's JUICEE GUMMEE marks.


16. If Applicant is granted a registration for the mark herein opposed, it will obtain thereby a *prima facie* exclusive right to use YUMMY JUICY & Design, which will damage and injure Opposer, the prior and rightful owner and user of the JUICEE GUMMEE marks in the United States.

WHEREFORE, Opposer requests that registration of Serial No. 78/686,043 be denied and this opposition be sustained.






