1. Opposer and/or its predecessors have used the trademark “L.A. Looks” in Commerce since at least as early as September 1987 in association with hair care and hair styling preparations (“Opposer’s Goods”).

2. Since at least as early as September 1987, Opposer and/or its predecessors have engaged in the manufacture, distribution and sale of hair care and hair styling products in Commerce, in conjunction with the L.A. Looks trademark, and the mark has been in continuous use by Opposer and/or its predecessors since that time.

3. Opposer is the owner by assignment of United States Trademark Registration No. 1698676, a copy of which is attached hereto as Exhibit A, and which issued on July 7, 1992, for the trademark “L.A. Looks” for “hair care and hair styling products; namely, hair sprays and mousse” in International Class 3. The mark was first used in commerce in September 1987.

4. Opposer is the owner by assignment of United States Trademark Registration No. 1552432, a copy of which is attached hereto as Exhibit B, and which issued on August 22, 1989, for the trademark “LA L.A. Looks & Design” for “hair care and hair styling products, namely, styling gels, hair sprays and mousse” in International Class 3. This mark was first used in commerce in September 1987.

5. Opposer is the owner by assignment of United States Trademark Registration No. 2905187, a copy of which is attached hereto as Exhibit C, which issued on November 23, 2004, for the trademark “LA L.A. Looks & Design” for “hair care and hair styling preparations” in International Class 3. The mark was first used in commerce on November 27, 2002.

6. Opposer is the owner of United States Trademark Registration No. 3210950, a copy of which is attached hereto as Exhibit D, which issued on February 20, 2007, for the

trademark “LA L.A. Looks & Design” for “hair care preparations; hair styling preparations” in International Class 3. The mark was first used in commerce on January 6, 2006.

7. Opposer is the owner of United States Trademark Registration No. 3211480, a copy of which is attached hereto as Exhibit E, which issued on February 20, 2007, for the trademark “L.A. Looks Absolute Styling” for “hair styling preparations” in International Class 3. The mark was first used in commerce on January 31, 2006.

8. The above referenced registrations are all valid and, in addition, Registration No. 1698676 is incontestable.

9. Opposer has invested considerable effort and resources in advertising and promoting its mark L.A. Looks and the goods sold under the mark, with the result that the purchasing public has come to know, rely upon, and recognize the goods of Opposer by that mark. Opposer has established valuable goodwill in its mark L.A. Looks and the mark has become well known to the purchasing public.

10. Upon information and belief, Applicant is an individual with an address of 548 Brandon Place, Cliffside Park, New Jersey 07010.

11. On July 6, 2005, Applicant filed intent-to-use trademark application Serial No. 78/665105 for the mark “Look NY” for “cosmetics, namely, lip balm, face balm, foundations, lip coloring in the nature of lipstick and lip gloss, face cream, face cleanser, skin cream, skin cleanser, face moisturizer, skin lotion, hand lotion, face lotion, eye make-up, nail polish, nail cream, glitter cosmetics, perfume, body powder, and blush” in International Class 3 (“Applicant’s Goods”).

12. Application Serial No. 78/665105 was published for opposition in the USPTO Official Gazette of November 7, 2006. Opposer has obtained extensions of time to oppose this application to May 6, 2007.

13. There is no issue as to priority. Opposer has priority based on use and registration of its mark L.A. Looks in the United States. Opposer used and registered its mark L.A. Looks long before the Applicant's application date.

14. Applicant's proposed trademark is visually and phonetically highly similar to Opposer's mark L.A. Looks, and creates a commercial impression which is identical to or virtually identical to Opposer's mark.

15. The goods identified in Applicant's application are similar and/or related to the goods with which Opposer's mark L.A. Looks is used and for which it is registered, and Applicant's Goods are intended for sale to the same customers and through the same channels of trade.


16. Applicant's proposed trademark Look NY so resembles Opposer's trademark L.A. Looks as to be likely, when applied to Applicant's Goods, to cause confusion or to cause mistake or to deceive within the meaning of 15 U.S.C. §1052(d), in view of Opposer's prior use, ownership and registration of its trademark L.A. Looks.

17. Registration should therefore be refused under 15 U.S.C. §1052(d).

18. Registration of Applicant's proposed mark on the Principal Register would be inconsistent with Opposer's rights under the aforementioned registration, and its common-law rights, and would be damaging to Opposer.

**WHEREFORE**, Opposer prays that its opposition be sustained and that the registration sought by Applicant be refused.




