Trademark Registration No. **4192309** (application Serial No. **77175066** involved in Opposition No. 91183482), for the mark **Coke Cherry Zero**, was inadvertently issued on **August 21, 2012**. Accordingly, the above-identified application will be referred to the Commissioner for Trademarks for appropriate action.¹
