MOTION TO WITHDRAW AS REPRESENTATIVE

Counsel for Petitioner Jeff Brown, Tom Q. Ferguson and Courtney Bru of Doerner, Saunders, Daniel & Anderson, L.L.P., submit this Motion to Withdraw as Representative pursuant to 37 C.F.R. §§ 2.19(b) and 10.40(b)(4) and state as follows:

1. On December 21, 2007, counselor Rachel Blue, formerly affiliated with Doerner, Saunders, Daniel & Anderson, L.L.P., filed a Notice of Opposition on behalf of Petitioner Jeff Brown. (Dkt. No. 1.) Counselor Tom Q. Ferguson appeared with her on various pleadings and papers.

2. On October 13, 2008, Bru filed an entry of appearance indicating that she also represented Petitioner Jeff Brown. (Dkt. No. 9.)

3. Blue has previously left the firm of Doerner, Saunders, Daniel & Anderson, L.L.P. and joined the Firm of McAfee & Taft, 500 ONEOK Plaza, 100 West 5th Street, Tulsa, Oklahoma, 74103.

4. Before Blue left the firm of Doerner, Saunders, Daniel & Anderson, L.L.P., Blue and Bru jointly advised Petitioner Jeff Brown of that event. At that time Petitioner elected to have Blue continue to represent him in connection with this opposition. Petitioner understood

and agreed that those attorneys that remained affiliated with Doerner, Saunders, Daniel & Anderson, L.L.P. would ultimately withdraw from representation.

5. Shortly thereafter, Bru caused Doerner, Saunders, Daniel & Anderson, L.L.P. to turnover to Blue all papers and property that relate to the instant opposition and to which Petitioner is entitled. Those papers and property have henceforth been in the possession, custody and control of McAfee & Taft.

6. Blue has consistently represented Petitioner in this matter and continues to do so. As such, Petitioner will not be prejudiced by this request for withdrawal.

7. By letter dated October 8, 2009, Bru again gave due notice that Doerner, Saunders, Daniel & Anderson, L.L.P. would withdraw from representation of Petitioner.

8. Doerner, Saunders, Daniel & Anderson, L.L.P. received no advance payments for services performed.
