**STONCOR’S MOTION FOR A THREE WORKING DAY
EXTENSION OF TIME TO FILE REPLY BRIEF**

StonCor through its undersigned counsel hereby moves this Board for a three working day extension of time to file StonCor’s Reply Brief.

The well-publicized inclement weather and record snow falls in the middle Atlantic states on Saturday February 6th and on Wednesday February 10th reduced, by three working days, the time available for StonCor’s preparation and filing of StonCor’s reply brief, necessitating the filing of the instant motion.

During the night and into the day on Saturday February 6th, the suburban Philadelphia area around StonCor’s counsel’s office received approximately 24 inches of snow. During the day on Wednesday February 10 the suburban Philadelphia area around StonCor’s counsel’s office received approximately 20 additional inches of snow.

StonCor's undersigned counsel's offices were closed Wednesday and Thursday February 10th and 11th and reopened today with significant numbers of employees still unable to come to work due to the snowfalls.
