**NOTICE OF OPPOSITION**

The H.D. Lee Company, Inc., a Delaware corporation located and doing business at 3411 Silverside Road, Wilmington, Delaware 19810 (“Opposer”) believes it will be damaged by the issuance of a registration to GRENDENE S.A. (“Applicant”) for the mark RIDER (Serial No. 76/669,723) in International Class 25 and hereby opposes the application in that class.

As grounds for the opposition, Opposer avers that:

1. Applicant has filed an intent-to-use application to obtain, under the provisions of the Trademark Act of 1946, as amended (the “Trademark Act”), registration on the Principal Register of the mark RIDER for “footwear” in International Class 25.

2. Applicant is not now and never was entitled to registration on the Principal Register of the mark RIDER, either on November 30, 2006, the date of the filing of the application, or on August 22, 2007, the date of publication in the Official Gazette.

3. For many years, Opposer, by itself, and/or through its predecessors and related companies and licensees, has been engaged in the business of manufacturing, distributing, selling and promoting clothing in interstate commerce throughout the United States.

4. Opposer is the owner of the United States trademark registration nos. 2,898,246; 2,571,259; 1,848,233; and 2,013,089 for RIDERS and RIDERS R for “clothing, including dresses, socks, and hosiery, footwear, jeans, casual pants, shirts, T-shirts, sweatpants, sweatshirts and sweat shorts” in International Class 25 and registration no. 602,438 for STORM RIDER for “outer jackets for men, women, boys, and girls.” Opposer is also the owner of prior pending United States trademark application nos. 78/759,456 and 78/775,928 for “clothing namely, jeans, capri pants, denims, pants, casual pants, jogging pants, sweat pants, sweat shirts, shirts, t-shirts, sport shirts, golf shirts, short-sleeved shirts, long sleeved t-shirts, knit shirts, and dress shirts; footwear namely, shoes, hosiery, and socks; headgear namely, caps, hats, visors, baseball caps, and knit caps; belts and suspenders.”

5. Opposer began using the RIDERS trademark in interstate commerce for clothing long prior to Applicant’s filing its application to register the mark RIDER, at least as early as August 2, 1994 and Opposer began using the STORM RIDER trademark in interstate commerce for clothing at least as early as November 16, 1953.

6. Opposer continues to offer, advertise and sell clothing under the RIDERS and STORM RIDER marks throughout the United States and has thus created valuable goodwill in the marks.

7. Applicant has created a mark that is likely to be perceived as emanating from Opposer by the simple singularization of Opposer’s RIDERS marks. Thus, registration of

Applicant's mark is likely to cause confusion, mistake, or deception among the general and consuming public as to the source, sponsorship or affiliation of Opposer's products.

8. If Applicant is granted the registration herein opposed, Applicant will obtain a prima facie exclusive right to use in commerce, as of the registration date, its claimed mark RIDER in connection with the goods specified in its application. Such registration is inimical to a superior right of Opposer to use the mark in connection with goods in the same classification, and thus a source of injury to Opposer.

For the foregoing reasons, Opposer will be damaged by registration of the mark of Applicant.


WHEREFORE, Opposer requests that registration of the mark RIDER, Application Serial No. 76/669,723, be denied to Applicant and this opposition be sustained.
