**NOTICE OF OPPOSITION**

Opposer, Match.com, L.L.C. (“Match.com”), a limited liability company existing under the laws of the state of Delaware and having an address of P.O. Box 25458, Dallas, Texas 75225, believing it will be damaged by registration of “MATCHNOTES” as a trademark in International Class 45 for “Online social networking services” as shown in Serial No. 77175830, hereby opposes same.

As grounds for opposition, Match.com alleges as follows:

1. Applicants, Ivory Li and Laurence Hughes, seek registration of “MATCHNOTES” as a trademark in International Class 45 for “Online social networking services” (“the Subject Services”).
  
2. Applicants filed Application Serial No. 77175830 on May 8, 2007, claiming a *bona fide* intent to use the mark pursuant to Section 1(b) of the Trademark Act. As of the present date, however, Applicants have not begun using the mark in commerce in connection with the Subject Services.
  
3. Match.com is the owner of a family of “MATCH” trademarks relating to online dating and social interaction and/or related services (collectively the “Match Marks”), including the following registered marks or pending applications:

4. Match.com also owns a series of common law trademarks as part of its family of “MATCH” marks, including MATCH STUDIOS, MY MATCH, and MATCH MY FRIENDS. Over the years, Match.com has also used other MATCH marks.
5. Match.com, its licensees, and/or its predecessors-in-interest, have used the Match Marks in interstate commerce in connection with online dating and social interaction and/or related services since at least as early as March 1995. Such use is well before the May 8, 2007 filing date of Application Serial No. 77175830.
6. Match.com, its licensees, and/or its predecessors-in-interest, have invested significant resources advertising and promoting goods and services sold under the Match Marks, and has used the marks in connection with the millions of dollars worth of goods and services. As such, consumers and others view the Match Marks as a famous family of marks, and regard Match.com as the origin of goods or services sold under the “MATCH” prefix and the MATCH mark itself, especially when such goods or services relate to online dating or social interaction.
7. Upon information and belief, Applicants will offer the Subject Services under the MATCHNOTES mark to a variety of customers, many of whom are likely to be familiar with, or actual purchasers or users of, service offered or provided by Match.com in connection with one or more of its Match Marks.

8. As may be seen by comparing the marks at issue, Applicants' MATCHNOTES mark appropriates Match.com's MATCH mark in its entirety. The addition by Applicants of the "NOTES" suffix to the MATCH mark is unlikely to dispel confusion and, in fact, will likely heighten confusion as many consumers are apt to believe that "MATCHNOTES" is merely yet another MATCH-branded services offered by Match.com under its family of Match Marks, similar to MATCHWORDS, MATCHTALK, MATCHTRAVEL, or MATCH STUDIOS.
9. Applicants' proposed use of MATCHNOTES in connection with the Subject Services thus is likely to cause consumers mistakenly to believe that such services provided are somehow related to Match.com or the Match Marks, or that such services originate from, or are sponsored or approved by, Match.com (or vice versa). This confusion and mistake is likely to cause injury to Match.com.
10. If Applicants are awarded a registration for MATCHNOTES in connection with the Subject Services as shown in Serial No. 77175830, they would be entitled to the presumptions flowing from such a registration, all to the injury of Match.com.
11. Concerned about the potential for confusion and for harm, Match.com timely filed two requests for extensions of time to oppose the subject application and is now filing this Notice of Opposition, all within the prescribed statutory periods.

12. Match.com has not given Applicants permission or approval to use the mark MATCHNOTES, or to incorporate the MATCH designation into any mark.
13. Accordingly, registration for the mark applied for under Serial No. 77175830 should be refused under the provisions of Section 2(d) of the Trademark Act.
14. Applicants' proposed use of MATCHNOTES to identify the Subject Services would also dilute the distinctive quality of the famous Match Marks and cause dilution as set forth in Section 43(c) of the Trademark Act, injuring Match.com.
15. Accordingly, registration for the mark applied for under Serial No. 77175830 should also be refused under Sections 2 and 43(c) of the Trademark Act.

WHEREFORE, Opposer, Match.com, L.L.C., prays that Application Serial No. 77175830 be rejected, that no registration be issued to Applicants, and that this opposition be sustained in favor of Match.com.
