NOTICE OF OPPOSITION

Valentino S.p.A., an Italian corporation, (hereinafter "Valentino") with an address at Via Turati, 16/18 I-20121, Milano, Italy, believes that it will be damaged by registration of the mark V in the Oval Design (hereinafter the "opposed mark") for: FACE AND BODY CREAMS AND LOTIONS IN INTERNATIONAL CLASS 3 as set forth in Application Serial No. 77/277,765, filed on September 12, 2007, and published on February 19, 2008 (hereinafter the "Application"), owned by Vanderveer, LLC, with an address at 6650 S.W. Redwood Lane, Suite 150, Portland, Oregon 97224 (hereinafter the "Applicant"), and hereby opposes the same. As grounds for this opposition, it is alleged that:

1. Since long prior to the use claimed in the Application, Valentino has extensively used, advertised and promoted the marks "V and Oval Design," "VALENTINO GARAVANI V and Oval Design," and "VALENTINO V and Oval Design," (hereinafter the "Valentino Marks") amongst others for cosmetics and a wide variety of clothing, handbags, spectacles, jewelry, leather goods, and related accessories.

2. Valentino is the owner and user (by assignment or otherwise) of the following U.S. registrations, among others:

- Registration No. 3,120,854, registered on July 25, 2006 for V stylized for soaps for personal use, perfumery, essential oils for personal use, cosmetics, hair lotions, dentifrices in Class 003; and
- Registration No. 2,740,997, registered on July 29, 2003, for V and Oval Design for a number of goods in classes 3, 9, 16, 18, 19, 20, 21, 24, 25, 27, 34, 35 including, face and body creams and lotions in Class 013;
- Registration No. 1,191,740, registered on March 9, 1982, for V and Oval Design for articles of clothing and accessories-namely, jumpers, sweaters, dresses, skirts, blouses, suits, jackets, coats, shirts, trousers, vests, jeans, slacks, shorts, swimwear, hats, lingerie, ties, scarves, hosiery in Class 025;
- Registration No. 1,268,030, registered on February 21, 1984 for VALENTINO V and Oval Design for articles of clothing and accessories, namely, jumpers, sweaters, dresses, skirts, blouses, suits, jackets, coats, shirts, trousers, vests, jeans, slacks, shorts, swimwear, hats, lingerie, ties, belts, scarves, hosiery and gloves in Class 025;

- Registration No. 1,418,315, registered November 25, 1986, for VALENTINO GARAVANI V and Oval Design for costume jewelry in Class 014;
- Registration No. 1,419,190, registered December 2, 1986, for VALENTINO GARAVANI V and Oval Design for, *inter alia*, valises, garment bags for travel, handbags, shoulder bags and small leather goods such as bill folds, wallets and credit card holders in Class 018;
- Registration No. 1,422,015, registered December 23, 1986, for VALENTINO GARAVANI V and Oval Design for articles of clothing—namely belts, scarves, gloves, boots, shoes and slippers in Class 025;
- Registration No. 2,315,165, registered on February 8, 2000, for V and Oval Design for spectacles frames and sunglasses in Class 009;
- Registration No. 2,755,270, registered on August 26, 2003 for VALENTINO GARAVANI V and Oval Design for, *inter alia*, retail store services featuring cosmetics, eye glasses and sunglasses, jewelry, watches and clocks, stationery, leather or imitation leather articles such as bags, purses, briefcases, address books, journals, and shoes in Class 035;
- Registration No. 2,826,869, registered on March 30, 2004 for VALENTINO GARAVANI V and Oval Design for, *inter alia*, spectacles frames and sunglasses in Class 009; men's and women's jewelry, watches and clocks in Class 014;

- Registration No. 2,880,581, registered on September 7, 2004 for VALENTINO GARAVANI V and Oval Design for, *inter alia*, valises, garment bags for travel, handbags, shoulder bags, clutch bags, brief cases, attache cases in Class 018; articles of clothing, namely, men's and women's suits, trousers, coats, jackets, shirts, belts, sweaters, scarves, swim wear, gloves, raincoats, pajamas, robes, vests, slacks, shorts, socks, stockings, boots, shoes and slippers, women's blouses, skirts, dresses, gowns, hosiery and lingerie, and men's ties and suspenders in Class 025;
- Registration No. 3,252,006, registered on June 12, 2007 for V and Oval Design for hand-operated hand tools and implements, namely, pincers, shears, slicers, choppers, hair clippers, food processors, lawn edgers; cutlery, forks and spoons; side arms, not including firearms, namely swords and hunting knives; razors in Class 008.

3. Each of the above-mentioned registrations is valid and subsisting and Registration Nos. 1,191,740; 1,268,030; 1,419,190; 1,418,315; 1,422,015; and 2,315,165 are incontestable. Print outs from the electronic database of the U.S. Patent and Trademark Office showing current status and title of the registrations listed above are attached as **Exhibit A-1 to A-12** to the Notice of Opposition.

4. Since 1959 in the U.S., Valentino has been synonymous with high fashion apparel and merchandise worn by the rich and famous and endorsed by movie stars and celebrities. Over time, Valentino has earned extensive critical review and acclaim for its

Valentino Marks including Valentino's V and Oval Design, VALENTINO V and Design, and VALENTINO GARAVANI V and Design.

5. Valentino has prominently and extensively used, advertised and promoted its marks. The Valentino Marks are regularly advertised in leading fashion magazines such as *Vogue*, *Harper's Bazaar*, *Elle*, *Marie Claire*, *W*, *Women's Wear Daily*, *Town & Country*, *Interview*, *M-The Civilized Man*, *Cosmopolitan*, *Time* and *GQ*. Valentino also makes consistent use of its Valentino Marks on corporate letterhead and promotional items.

6. Valentino has spent tens of millions of dollars on advertising, promoting and marketing its products under its Valentino Marks in the United States.

7. By virtue of the uncompromising and prestigious quality of the goods sold, advertised, and promoted under the Valentino Marks and by virtue of the extensive sales, promotion and advertising of such high quality goods for more than forty years, the Valentino Marks have become well-known and have acquired extensive recognition and strength throughout the United States.

8. The Valentino Marks are in the category of famous marks in the United States and acquired fame long prior to any date that Applicant can allege in connection with its alleged use of the opposed mark.

9. Upon information and belief, November 2005, is the earliest possible date Applicant can allegedly rely upon in this proceeding.

10. Applicant has no connection whatever with Valentino and no permission or license was given by Valentino to Applicant to use the V and Oval Design mark.

11. Valentino's use of the Valentino Marks in connection with cosmetics, and goods related thereto, namely, handbags, leather goods, clothing items, jewelry, footwear, hand tools, and eyewear is such that members of the public will perceive the opposed mark in close proximity with the Valentino Marks and mistakenly assume that the opposed mark emanates from Valentino and is one of the famous Valentino Marks.

12. The opposed mark so closely resembles Valentino's previously used and registered marks that its use, in connection with the goods aforementioned, is likely to cause confusion, or to cause mistake or deceive, in violation Section 2(d) of the Trademark Act of 1946, 15 U.S.C. § 1052 (d). Purchasers likely will assume that Valentino is somehow affiliated with, licenses, or endorses, Applicant's use of the opposed mark when Valentino is not connected in any way with Applicant or the intended use of the opposed mark.

13. If Applicant is permitted to use and register the opposed mark for the goods as specified therein, the damage to Valentino's goodwill and reputation will be enormous and irreparable. Such registration and use would dilute the singular, distinctive and unique quality of the famous Valentino Marks in violation of Section 43(c) of the Trademark Act of 1946, 15 U.S.C. § 1125(c).


14. The registration of the opposed mark will be inconsistent with Valentino's rights in the Valentino marks, the registrations pleaded above and Valentino's rights at common law and will be damaging to Valentino.

WHEREFORE, Valentino prays that this opposition be sustained and registration on the Application be refused.
