**NOTICE OF OPPOSITION**

Golfino AG, a corporation of Germany with its principal place of business at Humboldtstrasse 19 D 21509 Glinde, Germany (referred to hereinafter as "Opposer") believes that it is and will be damaged by registration of application Serial No. 77/104364- GOLF SPORT for " Dress shirts; Golf shirts; Polo shirts; Shirts; Short-sleeved or long-sleeved t-shirts; Short-sleeved shirts; Sport shirts " in Class 25, filed by Gady Desler and hereby opposes the same under the provisions of *Section 13 of the Trademark Act of July 5, 1946, 15 U.S.C. § 1063*. As grounds therefor, it is alleged that:

1. Opposer has, since long prior to February 10, 2007, the claimed priority date of Gady Desler (hereinafter referred to as "Applicant") for the trademark Golf Sport for " Dress shirts; Golf shirts; Polo shirts; Shirts; Short-sleeved or long-sleeved t-shirts; Short-sleeved shirts; Sport shirts ", been engaged in the manufacturing, offering and sale of clothing in commerce with the United States and in interstate commerce under the trade name and trademark GOLFINO as well as with a stylized logo of a golfer.

2. Opposer has engaged in the business of manufacturing and selling clothing in numerous countries around the world since 1986, including the United States since 2001 under the trade name and trademark GOLFINO as well as use with a stylized logo of a golfer, as follows:



3. Opposer is the owner of, among others, the following federally registered GOLFINO trademarks for use in connection with clothing:

GOLFINO & design- Registration No. 2,612,951, registered August 27, 2002, for clothing, namely, hats, visors, caps, shoes, socks, stockings, leggings, knickers, pants, shorts, gloves, scarves, jumpers, sweaters, vests, shirts, T-shirts, skirts, vests, undershirts, underpants, sweatshirts, golf shirts, jackets, rain jackets and tank tops;

GOLFINO & design- Registration No. 2,294,869, registered November 30, 1999, for golf articles, golf equipment, namely, golf putters, golf balls, golf bags and golf clubs; and


GOLFINO & design - Registration No. 2,788,307, registered December 2, 2003, for Leather and imitation leather sold in bulk; articles made from leather and imitation leather, namely trunks for traveling, travel bags, purses, pocket wallets, key cases; garment bags for travel, knapsacks, backpacks, cosmetic cases sold empty, handbags; brief cases; book bags, shopping bags, overnight travel cases.

A copy of each of the above registrations and related assignment information from TARR and ASSIGN, showing record title in Opposer (collectively, the "Golfino Marks") are attached to this Opposition as Exhibit A.

4. The certificates of registration identified in paragraph 3 are valid and subsisting and record title is in Opposer; the certificates of registration are *prima facie* evidence of the

validity of the registrations, the Registrant's ownership of the mark, and of the Registrant's exclusive right to use the mark in commerce in connection with the goods and services specified in the certificates of registration under the provisions of 15 U.S.C. § 1057(b) and constructive notice of the Registrant's claim of ownership under 15 U.S.C. § 1072. Registration No. 2,294,869 is incontestable, which provides conclusive evidence of its validity under 15 U.S.C. §1115(b).

5. On February 10, 2007, Applicant filed application Serial Number 77/104364 - GOLF SPORT for " Dress shirts; Golf shirts; Polo shirts; Shirts; Short-sleeved or long-sleeved t-shirts; Short-sleeved shirts; Sport shirts "



6. The Applicant's GOLF SPORT clothing and Opposer's GOLFINO clothing are identical products, used by the identical consumer for the same purpose of wearing while playing golf.

7. Upon information and belief, Applicant's GOLF SPORT clothing is sold and distributed through the same channels of trade and is sold in the same type of stores (golf stores and golf pro shops) and same section of general merchandise stores to the same classes of the purchasing public as Opposer's GOLFINO clothing.

8. Upon information and belief, the Applicant's GOLF SPORT clothing and Opposer's GOLFINO clothing are advertised and promoted through the same advertising media.

9. The designation GOLF SPORT which Applicant seeks to register is virtually identical to Opposer's trade name and trademark GOLFINO in sound, appearance and meaning.

Neither GOLFINO nor GOLF SPORT is a dictionary term, and so consumers cannot distinguish between the two marks on the basis that one or the other is a word in the English language. Such use by Applicant will cause both potential customers and customers to assume, erroneously, and to be confused, misled and/or deceived, that the Applicant's GOLFING clothing is affiliated with, endorsed, licensed, authorized or sponsored by Opposer and its GOLFINO clothing, all to the Opposer's irreparable damage.

10. The Opposer since long prior to the priority filing date of GOLF SPORT for clothing by the Applicant, has operated, built up good will and established client loyalty in using GOLFINO as its trade name, in the manufacture, distribution and sale of its GOLFINO clothing, and by reason of such, Opposer now enjoys a valuable goodwill and an enviable reputation with respect to its trade name and trademark GOLFINO for clothing.

11. Opposer's GOLFINO trade name and trademark has attained public recognition and acquired great value as an identification of the source of clothing in or by Opposer; and the said trade name and trademark distinguishes Opposer's goods from the goods of others.

12. For the reasons set forth in paragraph 1 through 11, Opposer believes, and believing asserts, that the goodwill in its GOLFINO trade name and trademark for clothing that it has developed over twenty (20) years of use will be damaged under Section 2(d), and that the Applicant should be denied the registration of the term GOLF SPORT for clothing.

13. By reason of the foregoing, Applicant's application of GOLF SPORT for clothing is likely to cause confusion with Opposer's GOLFINO mark for the same and is thus not registrable under Section 13 of the Trademark Act of 1946 (15 U.S.C. § 1063).

WHEREFORE, Opposer prays that this Opposition be sustained and that application Serial No. 77/104364- GOLF SPORT - be refused registration.

The fee of \$300.00 as provided by *Sections 13 and 31 of the Trademark Act of 1946* is paid by changing Opposer's attorneys' deposit account 501981.


