COMES NOW, Applicant, QA3, LLC , by and through its counsel, and for its Answer to Opposer's Notice of Opposition states and alleges as follows:


1. Applicant lacks knowledge or information sufficient to form a belief about the truth of the allegations of paragraph 1 and they are therefore denied.


