Opposer's consented motion (filed May 19, 2008) to suspend proceedings for settlement is granted. Accordingly, because the parties are negotiating for a possible settlement of this case, proceedings herein are suspended until **SIX MONTHS** from the mailing date of this action, subject to the right of either party to request resumption at any time. See Trademark Rule 2.117(c).

In the event that there is no word from either party concerning the progress of their negotiations, upon conclusion of the suspension period, proceedings shall resume without further notice or order from the Board, upon the schedule set out below.

Applicant is allowed **THIRTY DAYS** from resumption in which to answer the notice of opposition. Conferencing, disclosure, discovery and trial dates are reset as follows:

In each instance, a copy of the transcript of testimony together with copies of documentary exhibits, must be served on the adverse party within thirty days after completion of the taking of testimony. Trademark Rule 2.125.
