NOTICE OF OPPOSITION

Desert Glory Ltd. (“Opposer” or “Desert Glory”), a limited partnership organized and existing under the laws of the state of Texas, having its principal place of business at 15315 Capital Port, San Antonio, Texas 78249, believes that it will be damaged by registration of the mark shown in Application Serial No. 77/096,367 for the mark SWEET NATURE & Design in Class 32, filed by Far Side of the World Imports, Inc. (“Applicant”) on an intent-to-use basis and hereby opposes the same under the provisions of Section 13 of the Lanham Act, 15 U.S.C. § 1063.

As grounds of Opposition, Desert Glory asserts that:

1. Since at least as early as 1997, Desert Glory has adopted and continuously used the mark NATURE SWEET for fresh produce.
2. Desert Glory owns U.S. Registration No. 2,412,741 for the mark NATURE SWEET as a trademark registered in connection with the following goods:

Fresh fruit and vegetables, including fresh tomatoes in Class 31.

The United States Patent & Trademark Office (“USPTO”) issued U.S. Registration No. 2,412,741 on December 12, 2000, with Desert Glory having filed the underlying application on December 23, 1996. Desert Glory has continuously used NATURE SWEET in interstate commerce in connection with the specified goods since at least as early as 1997. Registration No. 2,412,714 is valid, subsisting and in full force and effect. A true and correct copy of the TARR record and USPTO Assignment Division record for the aforesaid registration are attached hereto as Exhibit A. The filing date for Registration No. 2,412,714 precedes Applicant’s filing date of January 31, 2007 and Desert Glory’s date of first use of the mark NATURE SWEET precedes Applicant’s filing date of January 31, 2007.

3. Desert Glory owns U.S. Registration No. 2,300,110 for the following composite word and design mark (hereinafter referred to as NATURE SWEET & Design):



as a trademark registered in connection with the following goods in Class 31:

Fresh fruits and vegetables.

The USPTO issued U.S. Registration No. 2,300,110 on December 14, 1999 with Desert Glory having filed the underlying application on January 27, 1999. Desert Glory has continuously used the NATURE SWEET Design Mark in interstate commerce in connection with the specified goods since at least as early as March 8, 1999. Registration No. 2,300,116 is valid, subsisting

and in full force and effect. A true and correct copy of the TARR record and USPTO Assignment Division records for the aforesaid registration are attached hereto as Exhibit B. The filing date for Registration No. 2,300,110 precedes Applicant's filing date of January 31, 2007, and Desert Glory's date of first use of the NATURE SWEET & Design precedes Applicant's filing date of January 31, 2007.

4. Desert Glory's marks referenced in paragraphs 1 through 3 will hereafter be referred to as "Opposer's Marks."

5. Opposer's Marks are inherently distinctive and serve to distinguish Opposer and the goods originating with Opposer from those of others, and to distinguish the source of Opposer's goods.

6. Desert Glory has expended substantial amounts of time, money and effort in advertising and promoting Opposer's Marks and the goods offered thereunder. As a result, Desert Glory has developed substantial goodwill in Opposer's Marks.

7. Applicant seeks to register the following composite word and design mark (hereinafter referred to as Applicant's Mark):



as a trademark in connection with the following goods in Class 32:

Aerated fruit juices; Aerated water; Ale; Aloe vera drinks; Aloe vera juices; Apple juice beverages; Beer; Beer-based coolers; Bottled drinking water; Bottled water; Coconut water;

Coffee-flavored soft drink; Colas; Concentrates, syrups or powders used in the preparation of soft drinks; De-alcoholized wines; Distilled drinking water; Drinking water; Energy drinks; Flavored waters; Flavoured waters; Frozen fruit beverages; Frozen fruit-based beverages; Fruit beverages; Fruit drinks; Fruit flavored soft drinks; Fruit juice bases; Fruit juice concentrates; Fruit juices; Fruit nectars; Fruit punch; Fruit-based soft drinks flavored with tea; Fruit-flavored beverages; Fruit-flavored drinks; Fruit-flavoured beverages; Ginger ale; Ginger beer; Glacial water; Grape juice beverages; Guarana drinks; Herbal juices; Iced fruit beverages; Imitation beer; Isotonic drinks; Juice based concentrates; Kvass; Lager; Lagers; Malt beer; Mineral water; Non-alcoholic beer; Non-alcoholic beverages containing fruit juices; Non-alcoholic beverages with tea flavor; Non-alcoholic beverages, namely, carbonated beverages; Non-alcoholic cocktail mixes; Non-alcoholic cocktails, namely, mocktails; Non-alcoholic fruit extracts used in the preparation of beverages; Non-alcoholic fruit juice beverages; Non-alcoholic honey-based beverages; Non-alcoholic malt beverage; Non-alcoholic malt coolers; Non-alcoholized wines; Non-carbonated, non-alcoholic frozen flavored beverages; Orange juice beverages; Pineapple juice beverages; Pop; Punch; Sarsaparilla; Scented water for making beverages; Seltzer water; Soda pops; Soda water; Soft drinks; Soft drinks flavored with tea; Sparkling water; Sports drinks; Spring water; Syrup for making lemonade; Syrups for beverages; Syrups for making beverages; Syrups for making soft drinks; Table water; Tomato juice; Tomato juice beverages; Vegetable juice; Vegetable juices (“Applicant’s Goods”).

This application was filed on January 31, 2007, subsequent to Opposer’s 1997 and 1999 dates of first use of Opposer’s Marks and the filing dates of both of the registrations for Opposer’s Marks.

8. Applicant’s Mark so resembles Opposer’s Marks as to be likely, when used in connection with Applicant’s Goods, to cause confusion, or to cause mistake, or to deceive. Purchasers and prospective purchasers are likely to falsely believe that Applicant’s Goods offered and provided under Applicant’s Mark are sponsored, endorsed, or approved by Desert Glory, or are in some way affiliated, connected, or associated with Desert Glory. Registration of Applicant’s Mark by Applicant should therefore be refused under 15 U.S.C. § 1052(d).

9. Registration of Applicant's Mark by Applicant would be a source of damage to Desert Glory because purchasers are likely to attribute the source or sponsorship of Applicant's Goods to Desert Glory.


10. Registration of Applicant's Mark by Applicant would be a further source of damage to Desert Glory because it would confer upon Applicant various statutory presumptions to which Applicant is not entitled in view of Desert Glory's rights in Opposer's Marks.

WHEREFORE, Desert Glory prays that Application Serial No. 77/096,367 be rejected and the registration of the mark therein be refused.

A fee in the amount of \$300.00 as required in 37 C.F.R. § 2.6(a)(17) is submitted herewith. If the amount is insufficient, or should any additional fees under 37 C.F.R. § 2.6 be required for any reason relating to the enclosed materials, or should an overpayment be included herein, the Commissioner for Trademarks is authorized to deduct or credit said fees from or to Fulbright & Jaworski Deposit Account No. 06-2380.


