NOTICE OF OPPOSITION

Opposers, Aidan Tracey, a Canadian individual, and Small World Net Corporation, a corporation duly organized and existing under the laws of the country of Canada (collectively, "Opposers") each with an address at 1122 Balmoral Place, Oakville, Ontario, Canada, L6J 2C9, believe that they will be damaged by registration of the service mark ASMALLWORLD ("Applicant's Mark") by aSmallWorld Ltd. ("Applicant"), shown in U.S. Trademark Application Serial No. 78/979,411 as it relates to services in International Class Nos. 35, 36, 43 and 45, and hereby oppose registration of Applicant's Mark for these services. As grounds for this opposition, Opposers state as follows:

1. On information and belief, Applicant is a corporation duly organized and existing under the laws of the country of the United Kingdom, with offices at Eagle House, 110 Jermyn Street, London SW1Y 6RH, United Kingdom.

2. On information and belief, Applicant filed U.S. Trademark Application Serial No. 78/979,411 (“the Application”) on September 21, 2005, for ASMALLWORLD for the following services (“Applicant’s Services”): “on-line advertising and marketing services; advertising via electronic media and specifically the internet; promoting the goods and services of others by distributing advertising materials through a variety of methods; provision of advertising space by electronic means and global information networks; providing and rental of advertising space on the internet; dissemination of advertising for others via the internet; commercial information services and advice for members, provided online via a computer network; providing consumer product information via the internet; marketing by compilation and display of a variety of goods and services, on behalf of others, to permit customers and users to acquire information on and purchase goods and services; business advice and information provided on-line via computer network; general business networking referral services, namely, promoting the goods and services of others by passing business leads, business contacts and referrals among group members; employment hiring, recruiting, placement, staffing and career networking services and information provided on-line via computer network; organizing business competitions on-line via computer networks for the purpose of advertising and sales promotion; computerized collection of business information indices, namely, customer indexes, collection, preparation, composition, processing, acquisition and provision of business information in databases; management of computerized files” in International Class 35; for “providing information on insurance matters, financial services and real estate listings via the internet” in International Class 36; for “providing online reviews of restaurants and hotels” in International Class 43; and for “internet based dating services; providing information in the field of clothing rental online via computer network” in International Class 45.

3. Applicant alleged a Section 1(a) use basis for all classes of services in the Application. Applicant alleged dates of first use and first use in commerce of March 18, 2004, for all classes of services in the Application. Applicant alleged a priority date of May 31, 2005, based on the filing date of Applicant's European Community Trademark Application No. 442561.

4. Opposer Aiden Tracey owns U.S. Trademark Registration No. 2,640,310 ("the Tracey Registration") for IT'S A SMALL WORLD, filed February 14, 2000. The Tracey Registration issued on October 22, 2002. The application claimed a priority date of August 19, 1999, based on Canadian Application No. 1,025,943. The Tracey Registration alleges dates of first use and first use in commerce of July 24, 2002. The services listed in the Tracey Registration are "subscription based telecommunication computer service, delivered via the Internet, that provides on-line facilities for real time interaction with other computer users concerning a wide range of general interest topics" in International Class 38.

5. Opposer Small World Net Corporation owns U.S. Trademark Registration No. 3,137,789 ("the Small World Registration") for SMALL WORLD NET, based on Sec. 44(e), filed on May 7, 2000. The Small World Registration issued on September 5, 2006. The application claimed on a priority date of November 12, 1999, the filing date of Canadian Trademark Application No. 1,035,259. The Small World Registration is based on Canadian Trademark Registration No. TMA567065, issued September 9, 2002. The services listed in the Small World Registration are: "managing contact information between individuals or corporate customer service databases or departments to facilitate communication" in International Class 35; "telecommunications access services" in International Class 38; and "providing non-downloadable software for use in managing contact information between individuals or

corporate customer databases or departments to facilitate communication” in International Class 42. Collectively, IT’S A SMALL WORLD and SMALL WORLD NET are referred to herein as “Opposers’ Marks,” the Tracey Registration and Small World Registration are referred to herein as “Opposers’ Registrations” and the services in Opposers’ Registrations are referred to herein as “Opposers’ Services.”

6. Opposers have used Opposers’ Marks in connection with Opposers’ Services since long prior to Applicant’s alleged actual or constructive use of Applicant’s Mark for Applicant’s Services.

7. Under Sec. 33(a) of the Lanham Act (15 U.S.C. §1115(a), Opposers’ Registrations constitute “*prima facie* evidence of the validity of the registered marks and of the registration of each mark, of Opposers’ ownership of the marks, and of Opposers’ exclusive right to use Opposers’ registered marks in commerce on or in connection with the goods and services specified in the registrations. True copies of Opposers’ Registrations and the TARR records pertaining thereto are attached hereto as Exhibit A.

8. Applicant’s Application was filed long after Opposers began using Opposers’ Marks in interstate commerce in connection with Opposers’ Services. Opposers are the senior users and have priority over Applicant for the Applicant’s Services, which are highly related to Opposers’ Services in Opposers’ Registrations.

9. For many years, Opposers have continuously engaged in the sale and promotion of the high quality services in Opposers’ Registrations under and in connection with Opposers’ Marks. By reason of their efforts and by virtue of the excellence of the services offered and sold under Opposers’ Marks, the public and trade have come to recognize Opposers’ Marks as signifying Opposers and the services offered under and in connection with Opposers’ Marks, and

Opposers enjoy exceedingly valuable goodwill in connection with the services offered under and in connection with Opposers' Marks.

10. Applicant's Mark is confusingly similar to Opposers' Marks and the services set forth in Applicant's Application are similar to or highly related to the Opposers' Services provided by Opposers under Opposers' Marks. If Applicant is permitted to use and register its ASMALLWORLD mark for its services as specified in Applicant's Application herein opposed, such registration and use by Applicant are likely to cause confusion, mistake and deception and will seriously damage Opposers, Opposers' reputations and the goodwill that Opposers have established in Opposers' Marks, resulting in loss of sales and other damage to Opposers. Moreover, actual confusion is occurring among Opposers' customers and potential customers.

11. If this opposition is not granted and Applicant's registration issues, Applicant would have at least a *prima facie* exclusive right to use ASMALLWORLD in connection with the services recited in its Application. Such registration would be a source of damage and injury to Opposers.

12. Applicant has further damaged Opposers by filing cancellation proceedings against Opposers' Registrations (Cancellation Nos. 92048677 and 92048682), which proceedings are currently pending.

13. Use of ASMALLWORLD by Applicant is without Opposers' consent or permission.

14. Opposers each filed for and the Board granted extensions of time to July 2, 2008 to file this Notice of Opposition.

WHEREFORE, Opposers pray that this opposition be sustained and that registration of Applicant's Mark under Serial No. 78/979,411 be refused.

The PTO is authorized to deduct the filing fees for both Opposers for four classes for this Notice of Opposition and to debit any deficiency or credit any overpayment to Deposit Account No. 50-1965.

Applicant and Applicant's attorney of record/correspondent/domestic representative are being served a copy of this Notice of Opposition and Exhibit A at the correspondence addresses as shown in the TARR record for the Application, as noted in the attached Certificate of Service.

Opposer hereby consents and appoints Judith L. Grubner, Luke W. DeMarte and Gretchen Hosty Kotleba, members of the Bar of the State of Illinois, whose address is Michael Best & Friedrich LLP, 180 N. Stetson Avenue, Ste. 2000, Chicago, IL 60601, as its duly authorized agents and attorneys in the matter of the Opposition above identified, to prosecute said Opposition, to transact all business in the U.S. Patent and Trademark Office and in the U.S. courts in connection with this Opposition, to sign its name to all papers that may hereafter be filed in connection therewith and to receive all communications related to the same.
