NOTICE OF OPPOSITION

Celine S.A.. (“Opposer”), through its attorneys, believing it will be damaged by registration of the mark TOVA CELINE for “Jewelry made of precious metals and stones, namely, bracelets, earrings, rings, anklets, pendants, necklaces, cufflinks, tie racks, pins, watches, and watchbands” as shown in Application Serial No. 77209526, opposes this application pursuant to 37 C.F.R. § 2.104(b).

Opposer advises the Board that it is simultaneously filing an opposition against Application Serial No. 77207198 for the mark TOVA CELINE, which is also owned by Applicant. Both proceedings involve substantially similar issues of law and fact and may be consolidated in due course.

As grounds for its opposition, Opposer alleges that, upon actual knowledge with respect to itself and its own acts, and upon information and belief as to other matters:

Opposer and Its CELINE Mark and Name

1. Opposer Celine S.A. is an entity organized and existing under the laws of France and has a business address of 23/25, Rue du Pont Neuf, Paris, France.

2. Opposer owns the trademark and name CELINE for various products, including costume jewelry, clothing and accessories. Opposer has used its CELINE mark and name in commerce since at least as early as 1979.

3. Opposer owns numerous valid and subsisting U.S. trademark registrations for its CELINE mark and name, including the registrations set forth below:

4. The foregoing registrations are valid and subsisting and constitute *prima facie* evidence of the validity of the marks and registrations, of Opposer's ownership and

exclusive right to use the marks in commerce, and provide constructive notice of ownership thereof by Opposer.

5. Through its long use of the CELINE and CELINE-formative marks and names shown above (collectively, the "CELINE Marks"), and substantial advertising and promotion, Opposer has developed valuable goodwill in its CELINE Marks and these marks are strong and well-known.

Applicant and Its Mark

6. Tova Celine Chesnin ("Applicant"), the listed owner of the subject application, is an individual with an address of 3400 South Main Street, Los Angeles, California 90007.

7. On June 19, 2007, Applicant filed Application Serial No. 77209526 for the mark TOVA CELINE for "Jewelry made of precious metals and stones, namely, bracelets, earrings, rings, anklets, pendants, necklaces, cufflinks, tie racks, pins, watches, and watchbands" in Class 14.

8. Applicant's Application Serial No. 77209526 is based on intent-to-use.

9. Applicant's TOVA CELINE mark contains Opposer's CELINE mark in its entirety.

Likelihood of Confusion, 15 U.S.C. § 1052(d)

10. Opposer repeats and realleges each and every allegation set forth in Paragraphs 1 through 9.

11. Opposer has used its CELINE Marks in commerce well prior to the filing date of the subject Application Serial No. 77209526, and any date of first use that may be alleged by Applicant. Additionally, Opposer's registrations for its CELINE Marks

issued prior to the filing date of the subject Application Serial No. 77209526, and any date of first use that may be alleged by Applicant.

12. The goods set forth in Applicant's TOVA CELINE application are identical and/or closely related to Opposer's products.

13. Applicant's TOVA CELINE mark so resembles Opposer's prior used and registered CELINE Marks as to be likely, when used in connection with Applicant's goods, to cause confusion, or to cause mistake, or to deceive under Section 2(d) of the Lanham Act, as amended 15 U.S.C. § 1052(d).

WHEREFORE, Opposer believes that it is being and will be damaged, and will be damaged, by the registration of the mark shown in Application Serial No. 77209526, and requests that the opposition be sustained, and that registration to Applicant be refused.
