ANSWER TO NOTICE OF OPPOSITION

Grupo Comercial Rool S.A. de C.V., a Mexican Corporation, hereafter (“Applicant”), hereby answers the Notice of Opposition of Proximo Restaurants LLC, hereafter (“Opposer”), as follows:

1. As to the introductory paragraph set forth in the Notice of Opposition, Applicant denies that Opposer will be damaged by registration of its mark, U.S. Serial No. 77287412. Registrant is without knowledge or information sufficient to form a belief as to the truth of the allegations remaining in the introductory paragraph of the Notice of Opposition, and therefore denies the same.

2. Registrant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in paragraph 1 of the Notice of Opposition, and therefore denies the same.

3. Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in paragraph 2 of the Notice of Opposition, and therefore denies the same.
4. Applicant admits that Opposer is the owner of U.S. Registration 1822109 filed August 28, 1992 and registered February 15, 1994 for the mark Jaleo covering RESTAURANT SERVICES.
5. Applicant admits the allegations contained in paragraph 4 of the Notice of Opposition.
6. Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in paragraph 5 of the Notice of Opposition, and therefore denies the same.
7. Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in paragraph 6 of the Notice of Opposition, and therefore denies the same.
8. Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in paragraph 7 of the Notice of Opposition, and therefore denies the same.
9. Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in paragraph 8 of the Notice of Opposition, and therefore denies the same.
10. Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in paragraph 9 of the Notice of Opposition, and therefore denies the same.
11. Applicant denies allegations contained in paragraph 10 of the Notice of Opposition.

12. Applicant denies allegations contained in paragraph 11 of the Notice of Opposition.
13. Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in paragraph 12 of the Notice of Opposition, and therefore denies the same.
14. Applicant is without knowledge or information sufficient to form a belief as to the truth of the allegations contained in paragraph 13 of the Notice of Opposition, and therefore denies the same.

Applicant also claims that Opposer is misusing the “Hispanic” term in referring to its trademark. The “Hispanic” term refers to things related to those of Hispanic countries (e.g. Mexico, Chile, Panama, Argentina, Spain, etc.), a broad term that encompasses many Countries, but eventhough considered “Hispanic” each country is different and can not be confused with each other. Opposer’s mark specializes in SPANISH food NOT Hispanic food. It would be like stating that trademarks such as Mc Donald’s, Burger King, Wendy’s, etc are restaurants that specialize in “Anglo Foods”.

As shown in Opposer’s “Exhibit 5” the Opposer’s mark Jaleo for restaurant services specializes in SPANISH food, not Mexican food. Applicant’s mark is for Tequila, a world known MEXICAN alcoholic beverage, not a Spanish beverage. Opposer’s consuming public is sophisticated and capable enough of distinguishing one country from the other.

15. Applicant denies allegations contained in paragraph 14 of the Notice of Opposition.

The Opposer’s claim is groundless; the trademarks shown in Exhibit 6, 7, 8 and 9 are all Restaurants specializing in Mexican food or a combination of Mexican food Americanized, not Spanish Restaurants. Also, the trademark ANTONIO’S is not registered in class 42/43 nor in class 33 (see EXHIBIT 1). Trademark

CASA MAGNA is only registered for class 42 for hotel, restaurant, lounge and catering services, not in class 33 (see EXHIBIT 2).

16. Applicant denies allegations contained in paragraph 15 of the Notice of Opposition.

Opposer's claim is groundless; the restaurant's specializing in "Tequila" offer besides the Tequila Specialty for beverages, Mexican Food, therefore the specialization in offering tequila in their restaurants. The evidence provided by Opposer as "Exhibits 11, 12, 13 and 14" are registrations only for Restaurant Services not Tequila, they are not multiple applications except for trademark THE MATADOR RESTAURANT TEQUILA BAR, which has not yet been registered. Also restaurant "El Jardin Restaurant and Tequila Bar" in Opposer's Exhibit 12 is not registered within the USPTO nor has an application been filed, on the contrary there is an existent trademark for "Le Jardin" registered in class 42 (see EXHIBIT 3).

Therefore, no likelihood of confusion between Opposer's mark (restaurant specializing in Spanish Food) and Applicant's mark (Tequila, an exclusive MEXICAN beverage) can be found.

17. Applicant denies the allegations contained in paragraph 16 of the Notice of Opposition.

Opposer's claims are groundless; only three trademarks (Margaritaville, Cabo Wabo and El Agave) were multiple applications of the 86 applications provided by Opposer in "Evidence 15". This does not prove any association between Applicant's Trademark for Tequila and Opposer's Servicemark providing Restaurant Services.

18. Applicant admits allegations contained in paragraph 17 of the Notice of Opposition and states that the trademarks contained evidence provided by Opposer in "Exhibit 6, 7 and 8" specialize in Mexican food not Spanish Food.

19. Applicant denies allegations contained in paragraph 18 of the Notice of Opposition.

Opposer's claims are groundless; the Trademark Office has granted numerous registrations for the same marks in Class 33 (alcoholic beverages) and Class 42/43 (Restaurant Services) filed by different parties without causing likelihood of confusion between them, including: EL CHARRO for class 42 with registration no. 1526184 (see EXHIBIT 4) and EL CHARRO for class 33 with registration no. 2344977 (EXHIBIT 5); HACIENDA for class 42 with registration no. 1331341 (see EXHIBIT 6) and HACIENDA for class 33 with registration no. 1202268 (see EXHIBIT 7); TIERRA DEL FUEGO for class 42 with registration no. 3224681 (see EXHIBIT 8) and TIERRA DEL FUEGO for class 33 with registration no. 2605525 (see EXHIBIT 9); MI TIERRA for class 43 with registration no. 2800185 (see EXHIBIT 10) and MI TIERRA for class 33 with registration no. 2684324 (see EXHIBIT 11); PANCHO VILLA'S CANTINA in class 42 with registration no. 2324727 (see EXHIBIT 12), and eventhough the mark has been cancelled it has coexisted with trademark PANCHO VILLA in class 33 with registration no. 1020679 (see EXHIBIT 13); CASA VIEJA for class 42 with application serial no. 76330933 (see EXHIBIT 14), which was allowed for Publication by the US Trademark office permitting coexistence with the trademark CASA VIEJA for class 33 with registration no. 2616061 (see EXHIBIT 15); CIELITO LINDO for class 42 with registration no. 2627406 (see EXHIBIT 16) and CIELITO LINDO for class 33 with application serial no. 77223182 that has been Published in the Official Gazette and Trademark Office has issued a Notice of Allowance (see EXHIBIT 17); MEXICAN FIESTA for class 42 with registration no. 2716028 (see EXHIBIT 18) and its foreign equivalent FIESTA MEXICANA for class 33 with registration no. 3175106 (see EXHIBIT 19).

20. Applicant denies allegations contained in paragraph 19 of the Notice of Opposition. Opposer's webpage provided as evidence shows that they do not specialize in offering tequila in their Spanish restaurant but rather they specialize in WINE (see EXHIBIT 20).

21. Applicant denies allegations contained in paragraph 20 of the Notice of Opposition.

Opposer's Jaleo mark specializes in SPANISH food not "Hispanic"; there is a big difference when one refers to something HISPANIC and something Spanish or Mexican, in this case. Eventhough Mexico is considered a Hispanic country this does not mean that all Hispanic countries have the same culture, traditions, foods, etc; the only thing they have in common is that they use Spanish as their native official language and that they are countries that were formerly ruled by colonial Spain; As mentioned previously, it would be like saying that restaurant like McDonalds, Burger King, Wendy's, etc, are ANGLO RESTAUARNTS, or that people will be confused between a England and The United States of America.

There are many differences between a Mexican restaurant and a Spanish Restaurant, which Opposer's consuming public is capable of distinguishing.

22. Applicant admits the allegations contained in paragraph 21 of the Notice of Opposition.

23. Applicant denies allegations contained in paragraph 22 of the Notice of Opposition; the channels of commerce are different.

24. Applicant denies allegations contained in paragraph 23 of the Notice of Opposition.

25. Applicant denies allegations contained in paragraph 24 of the Notice of Opposition.

Opposer's consumers are sophisticated; not everyone can afford dinning out and those who can access such commodities are capable of differentiating Applicant's mark origin (Mexico) and Opposer's Restaurant specialty (Spanish Food).

26. Applicant denies allegations contained in paragraph 25 of the Notice of Opposition.
27. Applicant admits the allegations contained in paragraph 26 of the Notice of Opposition.
28. Applicant admits the allegations contained in paragraph 27 of the Notice of Opposition.
29. Applicant denies allegations contained in paragraph 28 of the Notice of Opposition; the commercial impression each mark creates is completely different.
30. Applicant denies allegations contained in paragraph 29 of the Notice of Opposition.
31. Applicant denies allegations contained in paragraph 30 of the Notice of Opposition, no likelihood of confusion can result from the allowing both marks to coexist.

AFFIRMATIVE DEFENSES

Grupo Comercial Rool S.A. de C.V., hereby assert the following affirmative defenses, reserving the right to modify and expand these affirmative defenses up to and through the time of final adjudication:

1. The Notice of Opposition fails to state a claim upon which relief can be granted.
2. Opposer will not be damaged by the registration of the mark that is subject to Applicant's U.S. Application No. 77287412.
3. Opposer's claims are barred in whole or in part because there is no Likelihood of Confusion pursuant to Section 2(d) of the Lanham Act, between the mark that

is subject of Applicant's U.S. Application Serial No. 77287412 and the mark asserted by Opposer.

4. In view of the foregoing Applicant contends that this Notice of Opposition is groundless and baseless in fact and that Opposer has not shown in any manner how it is likely to be damaged by the continued registration of Applicant's mark. Opposer has failed to allege grounds sufficient to establish standing to maintain petition for cancellation.

WHEREFORE, Applicant requests that the Opposition against U.S. Application Serial No. 77287412 be dismissed in its entirety and that judgment be entered in Applicant's favor.

Winemaker's Note

Cabernet Sauvignon (88%) and Merlot (12%) grapes from the Roma Vista Vineyard, Sonoma were picked in late September and early October and fermented separately. Average must sugar was 23.2° Brix. The fermentations reached an average maximum 84°F and lasted 18 days. The lots were then blended and went to oak barrels where the wine underwent malolactic fermentation and aging until bottling in the summer of 1988. Total acid of the finished wine is 0.61% by volume.
