The grounds for opposition are as follows:

- 1. Opposer owns and operates a chain of well-regarded retail grocery and consumer product stores that sell goods bearing the mark LIVE BETTER, and has done so for many years. For many years, Opposer has also offered related health and wellness consumer incentive program services under the mark LIVE BETTER WELLNESS CLUB.
- 2. Opposer is the owner of the following federal registrations for the marks LIVE BETTER WELLNESS CLUB®, LIVE BETTER! WELLNESS CLUB® (and design),

- 3. The registrations for Opposer's LIVE BETTER Marks are valid and subsisting. Copies of TSDR report printouts from the electronic database records of the USPTO showing the current status of Opposer's LIVE BETTER Marks are attached hereto as Exhibit A.
- 4. Opposer is also the owner of a pending application to register the mark LIVE BETTER, Serial No. 85/504,994, for retail supermarket services, for which a Notice of Allowance has issued.
- 5. Since at least as early as January 24, 2007, Opposer has promoted and advertised its health and wellness incentive program services using Opposer's LIVE BETTER WELLNESS CLUB® and LIVE BETTER! WELLNESS CLUB® (and design) marks.

 Likewise, since at least as early as August 2009, Opposer has promoted and advertised consumer product goods sold in supermarkets and pharmacies under the marks LIVE BETTER® and LIVE BETTER® (and design), including, but not limited to: vitamin, herbal, and dietary supplements; lotions and ointments; dental care products; foot care products; and medications including analgesics and decongestants. Opposer's pending application for the mark LIVE BETTER covers retail supermarket services.

- 6. Applicant seeks to register the mark LIVE BETTER AMERICA for "providing a web site featuring information on fitness" in Class 41, and "providing a web site featuring information on health, nutrition and lifestyle wellness" in Class 44, as evidenced by publication of said mark in the Official Gazette on May 8, 2012.
- 7. Upon information and belief, Applicant will promote General Mills food products through one or more web sites branded with mark LIVE BETTER AMERICA.
- 8. The General Mills web site located at www.generalmills.com states that General Mills is one of the world's largest food companies, and that several General Mills brands occupy the number one or number two market positions. General Mills brand products include *Cheerios* and *Wheaties* cereals, *Green Giant* vegetables, *Gold Medal* flour, and the *Pillsbury* line of refrigerated dough. These products are sold in Opposer's retail grocery stores that also use and promote Opposer's LIVE BETTER Marks.
- 9. Applicant's use of the mark LIVE BETTER AMERICA to promote General Mills food products, which are sold in Opposer's retail grocery stores that also use and promote Opposer's LIVE BETTER Marks, is likely to cause confusion, mistake and/or deception.
- 10. The Application for the services herein opposed was filed on January 5,2012, based on Applicant's intent to use the mark in commerce.
- 11. Upon information and belief, Applicant did not use the mark LIVE BETTER AMERICA for the services covered in the Application in United States commerce prior to its constructive first use in commerce date of January 5, 2012.
- 12. Opposer's dates of first use in commerce for each of the Opposer's LIVE BETTER Marks (Registration Nos. 3,452,346; 3,491,210; 4,094,111; and 4,089,723), and

Opposer's filing date and constructive first use in commerce date for Serial No. 85/504,994, precede Applicant's constructive first use in commerce date of January 5, 2012.

- 13. Opposer's LIVE BETTER Marks have been in valid and continuous use since the respective first use dates of each mark and have not been abandoned.
- 14. Because of the substantial investment of time and resources to promote, advertise and enforce Opposer's LIVE BETTER Marks, consumers have come to associate Opposer's LIVE BETTER Marks exclusively with Opposer's goods and services.
- 15. Opposer's LIVE BETTER Marks and Applicant's mark are similar in sound, appearance, connotation, and overall commercial impression. Each of Opposer's LIVE BETTER Marks and Applicant's mark employ the identical phrase "LIVE BETTER" as a dominant element.
- 16. In the Application for the services herein opposed, there are no restrictions on trade channels, so it must be presumed that the services of the Application identified will travel through all trade channels appropriate for services of that type.
- 17. Upon information and belief, Applicant's services, "providing a web site featuring information on fitness," in Class 41, and "providing a web site featuring information on health, nutrition and lifestyle wellness" in Class 44, are intended to be marketed through the same channels of trade as the goods and services rendered in connection with Opposer's LIVE BETTER Marks.
- 18. Applicant's LIVE BETTER AMERICA mark as used in association with a web site featuring information on fitness in Class 41, a web site featuring information on health, nutrition and lifestyle wellness in Class 44, and as used in association with a web site that promotes food products such as the General Mills products referenced above, is confusingly

similar to Opposer's LIVE BETTER Marks because the marks are similar in sound, appearance and overall commercial impression.

- 19. Applicant's LIVE BETTER AMERICA mark as applied to the services set forth in Class 41 and Class 44 of the Application, and as applied to a web site that promotes food products such as the General Mills products referenced above, so resembles Opposer's LIVE BETTER Marks for the goods and services rendered therewith that it is likely to cause confusion, mistake and/or deception.
- 20. If Applicant is permitted to register LIVE BETTER AMERICA for the services set forth in Class 41 and Class 44 of the Application, confusion of the relevant trade and public is likely to result, which will damage and injure Opposer.
- 21. Any defect, objection to, or fault found with Applicant's services under the LIVE BETTER AMERICA mark would necessarily reflect on and seriously injure the reputation that Opposer has established for its goods and services.
- 22. If Applicant is granted a registration for the mark herein opposed, it would obtain thereby at least a prima facie exclusive right to use the mark. Such registration would be a source of damage and injury to Opposer.

WHEREFORE, The Great Atlantic & Pacific Tea Company, Inc. prays that registration of the mark of Application Serial No. 85/509,241 in International Class 41 be refused and that this opposition be sustained.

NOTICE OF OPPOSITION

In the matter of the application of Campo Verde Tucan S.A. de C.V. Corporation ("Applicant") for registration of the mark SUPER FRESH! BY GREEN TUCAN, Application Serial No. 85/320,885 (the "Application"), filed May 13, 2011 and published for opposition in the Official Gazette on September 27, 2011:

The Great Atlantic & Pacific Tea Company, Inc. ("Opposer"), a Maryland corporation, with offices at 2 Paragon Drive, Montvale, New Jersey 07645, believes that it will be damaged by the registration of the mark shown in the above-identified Application and hereby opposes the same. The grounds for opposition are as follows:

- 1. Opposer owns and operates a chain of well-regarded, quality retail grocery and consumer product stores bearing the mark SUPER FRESH, and has done so for many years.
- 2. Opposer is the owner of federal registrations for the marks SUPER FRESH®, Registration No. 2,085,126, and S SUPERFRESH® (and design), Registration No. 3,467,757, collectively referred to as "Opposer's SUPERFRESH Marks." Registration No. 2,085,126 is incontestable. Attached hereto as Exhibits A and B are current TARR report printouts from the electronic database records of the USPTO showing the current status and title of these registrations.

- 3. Since at least as early as July 14, 1982, Opposer has promoted and advertised the sale and distribution of goods or services bearing, or offered in connection with, Opposer's SUPERFRESH Marks, including, but not limited to, supermarkets and retail grocery and consumer product store services as well as grocery and consumer product goods, including fruits and vegetables.
- 4. Applicant seeks to register the mark SUPER FRESH! BY GREEN TUCAN (and design) for fresh fruit and vegetables in class 46, as evidenced by publication of said mark in the Official Gazette on September 27, 2011.
- 5. The Application for the goods herein opposed was filed on May 13, 2011, based on Applicant's intent to use the mark in commerce.
- 6. Upon information and belief, Applicant did not use the mark SUPER FRESH! BY GREEN TUCAN (and design) for the goods covered in the Application in United States Commerce prior to its constructive first use in commerce date of May 13, 2011.
- 7. Opposer's dates of first use in commerce for each of the Opposer's SUPERFRESH Marks, Registration Numbers 2,805,126 and 3,467,757, precede Applicant's constructive first use in commerce date of May 13, 2011.
- 8. Opposer's SUPERFRESH Marks have been in valid and continuous use since the respective first use dates of each mark and have not been abandoned.
- 9. Because of the substantial investment of time and resources nationally to promote, advertise and enforce Opposer's SUPERFRESH Marks, consumers have come to associate Opposer's SUPERFRESH Marks exclusively with Opposer's goods and services.

- 10. Each of Opposer's SUPERFRESH Marks and Applicant's mark employ the identical phrase "SUPER FRESH" as a dominant element.
- 11. In the Application for the services herein opposed, there are no restrictions on trade channels, so it must be presumed that the goods of the Application identified will travel through all trade channels appropriate for goods of that type.
- 12. On information and belief, Applicant's goods for fresh fruit and vegetables in class 46 are intended to be marketed through the same channels of trade as the goods and services rendered in connection with Opposer's SUPERFRESH Marks.
- 13. Applicant's SUPER FRESH! BY GREEN TUCAN mark as used in association with fresh fruit and vegetables in class 46 is confusingly similar to Opposer's SUPERFRESH Marks because the marks are similar in sound, appearance and overall commercial impression.
- 14. Applicant's SUPER FRESH! BY GREEN TUCAN mark as applied to the identification of goods in the Application so resembles Opposer's SUPERFRESH Marks for the goods and services rendered therewith that it is likely to cause confusion, mistake and/or deception.
