**REQUEST TO AMEND APPLICATION WITH CONSENT**

In accordance with 37 CFR §2.133(a), Applicant, through its attorneys, and with the consent of Opposer, hereby requests that its Application Serial No. 77/038,527 to register the trademark **PROFILE** be amended by deleting the following wording from its Class 19 goods description:

"fiber filtration tubes for use in erosion control, sediment control and/or storm water treatment."

Thus, the Class 19 goods description, as amended, will read:

"EROSION CONTROL BLANKETS; WOOD FIBER MATS FOR EROSION CONTROL;  
AND GEOTEXTILE MATTING FOR TURF REINFORCEMENT AND STABILIZATION."

The remaining Classes in the Application, Classes 1, 31, and 42, are not changed.




