**MOTION ON CONSENT TO CONTINUE SUSPENSION OF THE PROCEEDINGS
AND TO EXTEND DISCOVERY PERIOD IF OPPOSITION IS RESUMED**

Opposer, by and through counsel, hereby moves for an order continuing the suspension of the proceedings in this matter for a period of three (3) months, until **February 5, 2010**. Applicant's counsel consented to this motion, which is requested to allow the parties to continue to engage in settlement discussions. Since the last continuation, Opposer provided Opposer's counsel with its comments on the draft agreement and in turn, Opposer's counsel provided Applicant's counsel with a revised draft settlement agreement. The additional time is requested for Applicant's counsel to confer with Applicant, to provide its comments on the revised agreement to Opposer's counsel and for the parties to continue their negotiations in order to try to resolve any remaining issues in connection with a settlement of this Opposition. If accepted,

the settlement agreement would resolve this matter without the need to proceed with the Opposition.

In the event that the Board denies this motion, Opposer consents to an extension of time for Applicant to file an answer or otherwise respond to the Notice of Opposition until sixty (60) days after such denial.

If the Board grants this motion, the Board should also reset Applicant's time to answer or otherwise respond to the Notice of Opposition. Additionally, the parties request that six months of discovery be allowed and that the discovery cutoff be reset to six (6) months after the proceedings resume so that the parties will have the full period of discovery in the event that the matter is not able to be resolved. The trial periods and other periods should be reset accordingly.
