NOTICE OF OPPOSITION

C. & J. Clark International Limited, a United Kingdom corporation, with a place of business at 40 High Street, Somerset, United Kingdom BA160YA (hereinafter "Opposer"), believes it will be damaged by registration of CLARK'S REGISTER, U.S. Serial No. 77-275412 (hereinafter "Applicant's Mark") with respect to underwear, waist belts, socks, sweaters, swimwear, T-shirts, shorts, pants, shirts, leather belts, gloves, hats, jackets, jeans, coats, belts in international class 25 (hereinafter "Opposed Goods") filed by Clark's Register, Inc., a Virginia corporation having a place of business at 8075 Leesburk Pike, Suite 760, Vienna, Virginia 22182 (hereinafter "Applicant") and Opposer

hereby opposes registration thereof pursuant to Section 13 of the 1946 Trademark Act (15 U.S.C. §1063).

Opposer alleges the following grounds for opposing the registration of CLARK'S REGISTER in class 25:

1. Opposer is the owner of the trademark CLARKS as well as a family of CLARKS trademarks featuring the term CLARKS for a variety of goods, including without limitation, footwear and clothing (referred to hereinafter as the "CLARKS Marks").

2. Opposer is the owner of the following United States Trademark Registrations and Applications for its family of CLARKS Marks, all in class 25:

a) U.S. Registration No. 540,599 for CLARKS, registered on April 3, 1951 for boots, shoes and slippers for men, women and children;

b) U.S. Registration No. 691,307 for CLARKS, registered on January 12, 1960 for footwear for men, women and children, namely, boots, shoes, slippers, sandals, overboots, overshoes and galoshes;

c) U.S. Registration No. 1,436,513 for CLARKS, registered on April 14, 1987 for footwear;

d) U.S. Registration No. 2,344,417 for CLARKS for belts;

e) U.S. Application Serial No. 77/083,763 for CLARKS, filed on January 16, 2007 and Allowed by the PTO, for clothing, namely, shirts, T-shirts, pants, shorts, blouses, skirts, dresses, hosiery, belts, suspenders, coats, jackets, ties, scarves, sweaters, pullovers, vests, gloves, hats, caps, shoes, boots and sandals;

f) U.S. Registration No. 3,266,446 for CLARKS COMFORT WOOL for socks;

g) U.S. Registration No. 3,198,790 for CLARKS ARTISAN for footwear, namely, shoes, boots, clogs and sandals;

h) U.S. Registration No. 3,101,782 for CLARKS ARTISAN COLLECTION for footwear, namely, shoes, boots, clogs and sandals;

i) U.S. Registration No. 1,509,328 for CLARKS ORIGINALS for footwear;

j) U.S. Registration No. 3,256,483 for CLARKS ORIGINALS & Design for footwear etc.;

k) U.S. Registration No. 1,276,247 for CLARKS STREET ESTABLISHED 1825 & Design for footwear;

l) U.S. Registration No. 3,336,561 for CLARKS UNSTRUCTURED for footwear etc.;

m) U.S. Registration No. 3,327,744 for CLARKS XTRAFIT for footwear and insoles;

n) U.S. Registration No. 2,897,226 for INDIGO BY CLARKS for footwear etc.;

o) U.S. Registration No. 3,196,585 for INDIGO BY CLARKS for hosiery, footwear, etc.;

p) U.S. Registration No. 2,954,724 for INDIGO BY CLARKS footwear etc.

q) U.S. Registration No. 3,196,586 for INDIGO BY CLARKS for hosiery, footwear, etc.

r) U.S. Registration No. 3,327,746 for XTRAFIT BY CLARKS for footwear and insoles, etc.;

s) U.S. Registration No. 2,990,367 for PRIVO CLARKS for footwear, hosiery and belts, etc.

Copies of the registration and application records from the USPTO TARR database are attached herewith as Exhibit A and made of record in this proceeding pursuant to Trademark Rule 2.122(d).

3. C. & J. Clark America, Inc. is the exclusive licensee of the CLARKS Marks in the United States and distributes and sells CLARKS products in the United States.

4. As a result of use and registration the CLARKS Marks identified above, Opposer has a valid and exclusive right to the CLARKS Marks for use on or in connection with a wide variety of goods and services, including clothing and footwear in class 25.

5. Opposer's rights in the CLARKS Marks are prior in time to any alleged first use or intent to use application by Applicant for Applicant's Mark.

6. In view of the similarities between Applicant's Mark and Opposer's CLARKS Marks, there is a likelihood that Applicant's Opposed Goods offered under the opposed mark will be seen as being sponsored by Opposer.

7. Applicant's Mark is likely to cause confusion, mistake or to deceive with Opposer's CLARKS Marks, within the meaning of Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d).

8. The use and registration of CLARK'S REGISTER by Applicant will damage Opposer in the selling of its goods and services and cause confusion among purchasers.

9. Clark's Register of 150 Chestnut Street, Providence, RI, and Opposer entered into an Agreement dated October 13, 1999 under which Clark's Register agreed that it would not "seek to register CLARK'S REGISTER, or CLARKS, or any similar term alone or in combination with any other word or device, in connection with the sale,

manufacture, or distribution of clothing, including footwear, including in connection with clothing or shoe store services, or clothing or shoe mail order services, anywhere in the world” (hereinafter “the Agreement”).

10. The Agreement between Clark’s Register and Opposer is binding upon all successors and assigns to Clark’s Register.

11. Upon information and belief, Applicant is the successor in interest to Clark’s Register.

12. Upon information and belief, Applicant is bound to the terms and conditions of this Agreement.

13. Applicant’s filing of Application Serial No. 77-275412 for the mark CLARK’S REGISTER with respect to underwear, waist belts, socks, sweaters, swimwear, T-shirts, shorts, pants, shirts, leather belts, gloves, hats, jackets, jeans, coats, belts in international class 25 is a violation of the Agreement.

14. Applicant is barred and estopped from pursuing the opposed application by the Agreement.

15. Applicant’s filing of the opposed application is a breach of the Agreement.

16. Because of the high degree of distinctiveness of Opposer’s family of CLARKS Marks, the length of time and extent to which Opposer has used its CLARKS Marks, the extensive publicity Opposer’s CLARKS Marks have received, the nationwide trading area in which Opposer’s CLARKS Marks are used, and the high degree of customer recognition of the Opposer’s Marks, CLARKS is a famous trademark pursuant to 15 U.S.C. § 1125(c)(1).

17. Registration of Applicant's Mark for the Opposed Goods identified in the application would lessen the capacity of Opposer's famous CLARKS Marks to identify and distinguish Opposer's products sold thereunder and, as such, would cause dilution of the CLARKS Marks in violation of 15 U.S.C. § 1125(c) and 1127.

18. Pursuant to 15 U.S.C. § 1063(a), as amended, Opposer believes it will be damaged by the registration sought by Applicant because such registration will support and assist Applicant in the infringing and diluting use of Applicant's Mark sought to be registered, and will give colorable exclusive statutory rights to Applicant in violation and derogation of prior and superior statutory and common law rights of Opposer.

19. For the reasons set forth herein, registration by Applicant of the mark CLARK'S REGISTER would seriously damage Opposer and should be refused because:

a) it is in violation of the Agreement;

b) use and/or registration of Applicant's Mark infringes upon Opposer's CLARKS Marks and is likely to cause customer confusion as to the source, origin, affiliation, or sponsorship between Applicant and Opposer; and

c) use and/or registration of Applicant's Mark for the Opposed Goods is likely to cause dilution of Opposer's famous CLARKS Marks.

WHEREFORE, Opposer prays that said application Serial Nos. 77/275412 be denied, that no registration be issued thereon to Applicant, and that this opposition be sustained in favor of Opposer.

Payment in the amount of \$300 is submitted herewith.
