





(referred to hereinafter as the “VERSUS marks”). Copies of the registration and application records from the USPTO TARR database are attached herewith as Exhibit A and made of record in this proceeding pursuant to Trademark Rule 2.122(d).

2. Opposer made first use of its VERSUS mark in the United States in November 1989 and consistent use has been made since that time.

3. As a result of prior use and registration of the VERSUS and VS marks identified above, Opposer has a valid and exclusive right to the VERSUS and VS marks for use on or in connection with various goods, including goods for the home.

4. As a result of the registrations of the VERSUS and VS marks identified above, Opposer has established a valid first use in interstate commerce of November 1989.

5. Applicant is the owner of Application Serial No. 77/409,485 for VS for vacuum cleaners.

6. Applicant filed its application Serial No. 77/409,485 on the basis of "intent to use" with the U.S. Patent and Trademark Office on February 29, 2008. Opposer's rights in the VERSUS and VS Marks are prior in time to any alleged first use or intent to use application by Applicant for Applicant's Mark.

7. Applicant's VS mark and Opposer's VERSUS and VS marks are identical in sound, meaning, and appearance. The goods provided by the parties in connection with their respective marks are sold via the same marketing channels and customers including Costco Stores; Target Stores; Amazon.com; Yahoo Shopping; Shopping.com; Shopzilla.com; Ebay.com; Nextag.com, etc.

8. In view of the similarities between Applicant's Mark and Opposer's VERSUS and VS Marks, there is a likelihood that Applicant's Opposed Goods offered under the opposed mark will be seen as being sponsored by Opposer.

9. Applicant's Mark is likely to cause confusion, mistake or to deceive with Opposer's VERSUS and VS Marks, within the meaning of Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d).

10. The use and registration of VERSUS by Applicant will damage Opposer in the selling of its goods and services and cause confusion among purchasers.

11. Because of the high degree of distinctiveness of Opposer's family of VERSUS and VS Marks, the length of time and extent to which Opposer has used its VERSUS and VS Marks, the extensive publicity Opposer's VERSUS and VS Marks have received, the nationwide trading area in which Opposer's VERSUS Marks are

used, and the high degree of customer recognition of the Opposer's Marks, VERSUS and VS are famous trademarks pursuant to 15 U.S.C. § 1125(c)(1).

12. Registration of Applicant's Mark for the Opposed Goods identified in the application would lessen the capacity of Opposer's famous VERSUS and VS Marks to identify and distinguish Opposer's products sold thereunder and, as such, would cause dilution of the VERSUS and VS Marks in violation of 15 U.S.C. § 1125(c) and 1127.

13. Pursuant to 15 U.S.C. § 1063(a), as amended, Opposer believes it will be damaged by the registration sought by Applicant because such registration will support and assist Applicant in the infringing and diluting use of Applicant's Mark sought to be registered, and will give colorable exclusive statutory rights to Applicant in violation and derogation of prior and superior statutory and common law rights of Opposer.

14. For the reasons set forth herein, registration by Applicant of the mark VS would seriously damage Opposer and should be refused because:

a) use and/or registration of Applicant's Mark infringes upon Opposer's VERSUS and VS Marks and is likely to cause customer confusion as to the source, origin, affiliation, or sponsorship between Applicant and Opposer; and

b) use and/or registration of Applicant's Mark for the Opposed Goods is likely to cause dilution of Opposer's famous VERSUS and VS Marks.

WHEREFORE, Opposer prays that said application Serial Nos. 77/409485 be denied, that no registration be issued thereon to Applicant, and that this opposition be sustained in favor of Opposer.

Payment in the amount of \$300 is submitted herewith.


