STIPULATED MOTION RE TIME FOR OPPOSERS TO RESPOND TO APPLICANT'S
MOTION FOR SUMMARY JUDGMENT AND RELATED PAPERS IN DOCKET ENTRY
21

The papers constituting Docket Entry 21 were filed on 12 February, and have been indexed by the Board as a unitary filing.

Those papers in fact comprised "APPLICANT'S OPPOSITION TO MOTION TO DISMISS AND APPLICANT'S MOTION FOR SUMMARY JUDGMENT" (19 pages not including exhibits and certificate of service) and "APPLICANT'S OPPOSITION TO OPPOSERS' MOTION TO AMEND" (3 pages including certificate of service).

The rules provide different periods of time for responding to motions for summary judgment, for responding to other motions, and for responding to oppositions to motions.

Since the papers in docket entry 21 are intimately related and are likely to be addressed by the Board as a package, Applicant and Opposers have agreed, through their respective counsel, to apply the more liberal time period for responding to a motion for summary judgment to the entire filing.

Accordingly, the Board is respectfully requested to confirm that, pursuant to stipulation of counsel, Opposers have until Monday 15 March, 2010 to respond to Applicant's Motion for Summary Judgment and to the included Oppositions to Opposers' pending motions.
