REASON TEXT	<p>On March 31, 2009, Applicant's outside counsel (Ashfords, of Exeter, U.K.) instructed me to take no further action with respect to Application Serial No. 77/248,780 or to the opposition filed thereto (Opposition # 91188973), and advised that Applicant had instructed another law firm to represent him. On April 4, 2009, Applicant directly filed an answer to the opposition which he signed electronically. On April 17, 2009 I asked Applicant's outside counsel to request Applicant to file a Revocation of Attorney/ Domestic Representative, and advised that if this was not filed, I would file a request for withdrawal as attorney of record..
