DECLARATION OF ROGER WILLIAMS

I, Roger Williams, hereby declare, under penalty of perjury, that the following is true and correct, to the best of my knowledge, information, and belief:

1. I am the sole member of Phoenix 2008, LLC, the Applicant in the above-captioned proceeding.
2. This Declaration is being submitted in support of Applicant's Response to Opposer's Motion to (1) Compel Applicant's Responses to Speed Channel's First Set of Requests for Production of Documents and Its First Set of Interrogatories; (2) Test the Sufficiency of Applicant's Responses to Speed Channel's Requests for Admissions; and (3) to Suspend, filed with the Board on September 28, 2009.
