This agreement entered on this day between Susino Umbrella Co. Ltd. and/or Heng Shun Ltd. (Susino) and Shu-Lian Shyu individually and/or on behalf one or more of her designated companies, ie. Ti Fu Enterprises, Ltd, Doppler Ltd., Sourcing Strategies Inc. (SLS).

The parties agree that on several occasions SLS obtains customers for the manufacturing contract of producing umbrellas with Susino companies.

The parties agree and recognize the essence of cooperation in maintaining these customers for mutual benefit.

Under such agreement, should one of SLS's customers make attempts to contact Susino directly, Susino will refer all matters to SLS, as it's sales representative for that customer.

If a recognized, established, or referred customer of SLS by happenstance or other means buys or contracts either directly or indirectly from Susino. Then Susino will guarantee to SLS and/or her designated companies a 5% commission on the gross sales to that particular customer.







They put our companies and reputation in grave economic danger and jeopardized our bond with US customs. We hold Mr. Anbang Wang personally responsible for this.

Once exposed, your client then afterwards demanded full payment contrary to our contractual agreement with them, at their own request, we asked them to return all goods back to them and refund our deposit payment. Then your client committed another fraud and falsified documents with the freight forwarder changing them after the ship sailed, a violation to International Shipping agreements, our directors have referred to this as a form of piracy, yet committing another fraudulent act. Take a look at their recent e-mail to me regarding they are not exporting goods to the USA, and then you claim they are and say not to rely on their words, as usual your client cannot come to the truth. I think you should tread carefully on how you pursue this case and know all the facts.

They are with unclean hands.

By not paying their former counsel, not taking exception to the TTAB's strong recommendation they seek counsel, giving them every opportunity to make an adequate proposal some 3 years later, it they that have lost all creditability.

Thanks for our your help. Firstly our past relationship has been very good up until last year with the big problem of quality. Now we have lost financially because we no longer have AS orders, Dyno orders, and now problems with Toppers orders.

We discussed Susino name in 2003-4 about buying the Dyno businesss to cooperate and launch Susino, this would have been for the best in my opinion. Mr. Wang choose not to go forward with that thinking, at that time we prepared presentation to bring Susino brand to USA as partnership, but it failed. Dyno was customer with us and we lost them because of these failed discussions.

We always discussed cooperation on Susino name in USA market, we always talk about cooperation, but nothing never happened. Mr Wang always ask for our plan, but he never gives his plan, now please Mr. Wang you are fully advised of all the situation and I want to know his plan. I went to Las Vegas when you asked me and when you launch Susino brand. In researching the trademark it expired in 2002/3. **This is not our doing, whoever handle this for Mr. Wang failed him, not us. Imagine if Totes or Futai did this, Mr. Wang should be thankful we catch this, but now our business in OEM is ruined by the quality issues. If Heng Shun did not fail us on the quality, we could discuss better future and partnership, but for us we are moving our orders to another factory to try to survive. So only left to discuss is whether he wishes to purchase trademark back or not. It is useless to attempt to litigate this issue, as the cost in legal fees far out weigh the cost to purchase the trademark back. Susino is on stock market is worth over 1.5 billion yuan, is this correct? To ask for \$7.5m yuan is small price to pay for the trademark back to Susino public company.**

Now the situation is desperate for OEM for us, no AS or Dyno orders, we failed storm duds; and even Stephanie worked on Four Seasons for business for nearly one year, when they finally decide to change supplier they purchase directly from factory. We did not complain or ask to be compensated for this.

Now we just received quality issue form Topper's, as below e-mail, Stephanie is being asked to visit them to review, but my thinking is the quality control at factory is disaster and can never recoup, at least on OEM. So all is left is Susino trademark at issue. It is clear Mr. Wang doesn't want partnership and wishes to be BOSS or BOSS, no need for partner.

In ending we will cannot defend poor quality whether OEM or not, Heng Shun or Susino ruined our business, if Susino is successful worldwide it is because sacrifice of our OEM business, and unfortunate for us that is all we have left. If Mr. Wang wants name brand back, he must consider all issues, our issues, our lost profit and customers and future profit, because we sacrifice our business for Susino brand worldwide success. My opinion is if Mr. Wang wants Susino name brand for USA he will need purchase the trademark or license it or cooperate with owner of trademark, because Susino does not have the trademark registered in USA, it is valuable asset for Susino public company. It is unfortunate this situation.


