JOINT MOTION TO WITHDRAWAL OPPOSITIONS AND CANCELLATION ACTIONS


The parties hereby file this Joint Motion to withdraw Consolidated Opposition No. 91190565 and the related counter-claim Cancellation Actions.

Children's Learning Adventure Licensing, LLC hereby withdraws the Cancellation Actions related hereto with the consent of the Opposer.


