OPPOSER'S NOTICE OF OPPOSITION

Opposer Luxury Goods International (LGI) S.A., a corporation duly organized and existing under the laws of Switzerland, with an address of Via Industria 19 6814, Cadempino ("LGI" or "Opposer"), believes that it would be damaged by the registration of the mark shown in the above-identified application, and hereby opposes the same, pursuant to 15 U.S.C. § 1063 and 37 CFR § 2.104.

As grounds for opposition, it is alleged that:

1. LGI is the owner of the entire right, title, and interest in the following valid, subsisting, and un-cancelled United States Federal trademark registrations (the "YSL Marks"):

and others (collectively referred to in the opposition as the YSL Marks).

2. Further, the mark YSL is incontestable for Registration Nos. 766,417, 1,208,578, 1,711,127 and 1,712,999, pursuant to Section 15 of the Trademark Act.

3. LGI is engaged in the sale and marketing of goods under the YSL Marks since a time long prior to the date of filing of Applicant's above application for registration.

4. LGI is and has been engaged in the sale and marketing in United States commerce of a variety of goods, including clothing and apparel, since at least as early as 1962.

5. Opposer has used Opposer's LGI Marks in commerce extensively and has acquired considerable and valuable goodwill and wide-scale recognition for Opposer's Marks. Opposer's Marks are famous and the public has come to associate Opposer's YSL Marks with Opposer and Opposer's goods. Opposer's YSL Marks have acquired distinctiveness.

6. Applicant Xtreme Soccer League, LLC (hereinafter "Applicant") is a corporation duly organized and existing under the laws of the State of Delaware.

7. Applicant filed application Serial No. 77/570,228 to register the mark XSL in Class 25 for an extensive range of goods.

8. Applicant's mark is confusingly similar to Opposer's YSL Marks and is likely, when applied to the goods of the Applicant, to cause confusion, or to cause mistake or to deceive.

9. Applicant's mark makes a highly similar commercial impression to Opposer's YSL Marks due to its virtually identical appearance. Applicant has merely converted the letter "Y" in Opposer's famous YSL design mark to an "X". The overall commercial impression of

Applicant's mark, when applied to the same or similar goods, would cause confusion or be likely to cause confusion, mistake, or deception.

10. Applicant's mark is the same or confusingly similar to Opposer's YSL Marks and Applicant's mark would be recognized as such.

11. Opposer is not connected with the activities performed by the Applicant under Applicant's mark.

12. Opposer's YSL Marks are of sufficient fame or reputation that when the Applicant's mark is used on its goods or services, a connection with the Opposer would be presumed.

13. Applicant's mark makes a highly similar, if not identical, commercial impression to Opposer's YSL Marks, due to use on identical and highly related goods as those offered under Opposer's marks.

14. Consumers encountering the Applicant's mark and goods are likely to believe that such goods originate from or are authorized or sponsored by the Opposer, in view of the wide-scale fame of the Opposer's YSL Marks and the insignificant differences between Opposer's YSL Marks and the Applicant's mark.

15. LGI's Yves Saint Laurent fashion company's marks have become associated with a range of goods including clothing and fashion accessories. Applicant's use of its marks for clothing and apparel which are identical or highly similar will be likely to lead consumers and potential consumers of the Applicant's goods to believe that the Applicant's mark is an addition to the Yves Saint Laurent and/or YSL family of marks, including Opposer's YSL Marks. The use of the Applicant's mark will cause consumers to see goods sold under the Applicant's trademark

as the natural result of a continuation or expansion of Opposer's YSL Marks, and believe that the Applicant's goods thus emanate from LGI.

16. On information and belief, the Applicant has adopted its XSL trademark with full knowledge of the Opposer's YSL Marks.

17. On information and belief, the Applicant lacks a bona fide intention to use its marks on all of the goods recited in its Application in International Class 25.

18. The Opposer's YSL Marks are famous trademarks.

19. Upon information and belief, the Applicant is not making commercial use of the Applicant's mark in commerce.

20. The Applicant's 1(b) intent to use application was filed after the first use of Opposer's YSL Marks in United States commerce.

21. The Applicant's 1(b) intent to use application was filed after Opposer's YSL Marks became famous.

22. Applicant's mark dilutes the quality of the Opposer's YSL Marks by diminishing the capacity of the Opposer's YSL Marks to identify and distinguish goods and services.

23. On information and belief, the Applicant's mark is also likely to diminish and dilute the value and distinctive character of Opposer's YSL Marks, to the great detriment of the Opposer's YSL Marks, which are famous, thus damaging the Opposer.

24. Applicant's XSL mark so resembles the Opposer's YSL Marks, as used in the United States and not abandoned, as to be likely to cause confusion, or to cause mistake or to deceive, or to dilute.

WHEREFORE, Opposer Luxury Goods International (LGI) S.A. prays that the application Serial No. 77/570,228 be refused, that no registrations be issued thereon to Applicant, and that this Opposition be sustained in favor of Luxury Goods International (LGI) S.A.
