Opposer's consented motion (filed April 15, 2013) to suspend proceedings to allow the parties' continued settlement efforts is granted. Proceedings herein are suspended until June 14, 2013, subject to the right of either party to request resumption at any time. See Trademark Rule 2.117(c).

In each instance, a copy of the transcript of testimony together with copies of documentary exhibits, must be served on the adverse party within thirty days after completion of the taking of testimony. Trademark Rule 2.125.

Briefs shall be filed in accordance with Trademark Rule 2.128(a) and (b). An oral hearing will be set only upon request filed as provided by Trademark Rule 2.129.
