NOTICE OF OPPOSITION

Lifetouch Inc., a Minnesota corporation having a principal place of business at Suite 400, 11000 Viking Drive, Eden Prairie, MN 55344 ("Opposer"), believes that it will be damaged by the registration of the mark LIFE TOUCH (stylized) shown in application Serial No. 77/646032 filed January 8, 2009 by World Fair International Limited ("Applicant"), and hereby opposes registration of the mark. The grounds for opposition are as follows:

1. By the application herein opposed, Applicant is seeking to obtain under the provisions of the Trademark Act of 1946, as amended, registration on the Principal Register of the mark LIFE TOUCH (stylized) for the following goods: "calculating machines; data processors; computers," in International Class 9.

2. Applicant's mark was published for opposition in the *Official Gazette* on August 4, 2009. Accordingly, this Notice of Opposition is timely filed.

3. Upon information and belief, Applicant filed its application to register LIFE TOUCH (stylized) on January 8, 2009 based on intent to use the mark in commerce. Upon information and belief, Applicant made no use of the mark LIFE TOUCH (stylized) in the United States prior to January 8, 2009.

4. Opposer owns the trade name LIFETOUCH and the following marks and corresponding United States trademark registrations (collectively, the “Opposer’s Marks”):

Opposer has continuously used Opposer’s Marks for the goods and services recited in the corresponding U.S. trademark registrations in interstate commerce since at least as early as the

respective First Use in Commerce dates noted above. Attached hereto as Exhibit A are details of these registrations printed from the United States Patent and Trademark Office Trademark Applications and Registrations Retrieval (TARR) database.

5. Opposer's registrations noted in paragraph 4, above, have not been cancelled, are valid, and are now in full force and effect.

6. Registration Nos. 1323758, 1647707, 1631112, and 1672864 are incontestable under Section 15 of the Lanham Act, 15 U.S.C. § 1065 and, consequently, these registrations are conclusive evidence of the validity of the registered marks and of the registration of the marks, of Opposer's ownership of the marks, and of Opposer's exclusive right to use the registered marks in commerce, under Section 33 of the Lanham Act, 15 U.S.C. § 1115.

7. Commencing long prior to Applicant's January 8, 2009 filing date Opposer has prominently used, and is now using, Opposer's Marks in commerce in connection with the goods and services noted in paragraph 4, above. Opposer has extensively advertised and promoted Opposer's Marks and has made substantial sales of goods and services under said marks. As a result of such use and promotion, Opposer's Marks have developed and represent valuable goodwill which inures the benefit of Opposer.

8. There is no issue of priority concerning application Serial No. 77/646032 since Opposer established use and registration of Opposer's Marks prior to Applicant's application filing date of January 8, 2009.

9. Applicant's claimed mark LIFE TOUCH (stylized) is substantially identical to and has the same commercial impression as Opposer's Marks.

10. Upon information and belief, Applicant's goods as set forth in Serial No. 77/646032 are marketed and purchased by the same or similar purchasers as those that purchase the goods and services identified in the registrations for Opposer's Marks.

11. Upon information and belief, Applicant's goods as set forth in Serial No. 77/646032 are marketed and distributed through the same or similar channels of trade as are Opposer's goods and services identified in Opposer's registrations for Opposer's Marks.

12. The goods as set forth in Serial No. 77/646032 are closely related to the goods and services identified in Opposer's registrations for Opposer's Marks.

13. Applicant's claimed mark LIFE TOUCH (stylized) for the goods noted in paragraph 1, above, so resembles Opposer's previously registered marks, noted in paragraph 4 above, as to be likely to cause confusion, or mistake, or deception in the trade and among purchasers as to the source, origin or sponsorship of Applicant's goods.

14. Due to the similarity of Opposer's previously used and registered marks and the related nature of the parties' respective goods and services, consumers are likely to view Applicant's goods as Opposer's goods or an extension of Opposer's goods and services marketed under a confusingly similar mark, causing damage to Opposer.

15. Registration of the mark shown in Application Serial No. 77/646032 will result in damage to Opposer under the provisions of Section 2(d) of the U.S. Trademark Act, 15 U.S.C. Section 1052(d), pursuant to the allegations stated above.

WHEREFORE, Opposer asks that its opposition to application Serial No. 77/646032 be sustained and that registration of the mark LIFE TOUCH (stylized) set forth therein be refused.
