NOTICE OF OPPOSITION

Harry Winston, Inc., a New York corporation of 718 Fifth Avenue, New York, N.Y. 10019, and its related and wholly controlled entity, Harry Winston S.A. a Swiss corporation, (collectively referred to hereafter as “Opposer”), believes that it is and will be damaged by registration of application Serial No. 77/684,833, for “retail stores featuring pet supplies” in Class 35, filed by HAIRY WINSTON, LLC, and hereby opposes the same under the provisions of *Section 13 of the Trademark Act of July 5, 1946, 15 U.S.C. §1063*. As grounds therefor, it is alleged that:

1. Opposer has since long prior to October 2, 2008 the alleged date of first use in commerce of HAIRY WINSTON, LLC’s (hereinafter referred to as “Applicant”) intent to use trademark application of HAIRY WINSTON Luxury Pet Boutique for retail

stores, been engaged in the business of producing and selling jewelry and timepieces, and operating retail stores under the trademarks WINSTON and HARRY WINSTON.

2. The Opposer has, since at least as early as 1932 been engaged in producing and selling jewelry, and operating retail jewelry stores in interstate commerce identified and distinguished by its WINSTON and HARRY WINSTON marks, by applying the marks to the goods, by labels on containers and packaging, by displaying representations of the marks in advertising and on retail store signs and in other ways customary to the trade.

3. Opposer's founder, the late Harry Winston, was a world-famous jeweler widely known as the "Jeweler to the Stars". Over the years, Harry Winston did business with royalty, famous people (such as Jacqueline Onassis) and countless Hollywood stars. He was immortalized by Marilyn Monroe in the 1953 movie "Gentlemen Prefer Blonds" when she sang the lyrics "talk to me Harry Winston, tell me all about it" in the song "Diamonds Are a Girl's Best Friend".

4. Opposer is the owner of the trademarks WINSTON and HARRY WINSTON, the United States Trademark Registrations thereof, and the goodwill symbolized by the trademarks and the registrations thereof for a variety of goods and services, including the following:

- a. WINSTON – Registration No. 848,629, Registered May 7, 1968, for jewelry and polished diamonds;
- b. HW HARRY WINSTON – Registration No. 1,747,040, Registered January 19, 1993, for jewelry, [sic] namely, crowns, necklaces, sets of jewels, brooches, bracelets, rings, earrings, cufflinks; horological and chronometric instruments; namely, write-watches, pocket watches, table watches, clocks, alarm-clocks, watch bracelets, bracelet fasteners, watch cases; jewel cases in precious metals, precious and semi-precious stones;

- c. HW HARRY WINSTON – Registration No. 2,112,912, Registered November 11, 1997, for handwriting instruments, namely, pens, fountain pens, ballpoint pens, writing pens;
- d. HW HARRY WINSTON THE OCEAN COLLECTION - Registration No. 2,461,192, registered June 19, 2001, for precious metals and their alloys sold in bulk; goods of precious metal or coated therewith, namely, crowns, necklaces, sets of jewels, brooches, bracelets, rings, earrings, cufflinks; jewel cases in precious metals; precious and semi-precious stones; jewelry, precious gemstones; chronometric instruments, namely, watches and clocks, watch bracelets, bracelet fasteners, watch cases; chronometers;
- e. HARRY WINSTON – Registration No. 3,616,973, registered May 5, 2009 for retail store services specializing in the sale of diamonds and rough diamonds;
- f. HARRY WINSTON – Registration No. 3,355,622, registered December 18, 2007 for jewelry and watches, namely, bracelets, earrings, rings, brooches, pendants, polished diamonds, precious and semiprecious gemstones, wrist-watches, pocket-watches, clocks, watch-bracelets, bracelets-fasteners, watch-cases and watch-movements.

Copies of registration numbers 848,629, 1,747,040, 2,112,912, 2,461,192, 2,593,490, 3,616,973 and 3,355,622 from TARR, along with Assignment print-outs for each registration are attached as Exhibits 1 and hereby made of record.

5. The certificates of registration identified in paragraph 4 are valid and subsisting and record title is in Opposer; the certificates of registration are prima facie evidence of the validity of the registrations, the Registrant's ownership of the mark, and the Registrant's exclusive right to use the mark in commerce in connection with the goods and services specified in the certificates of registration under the provisions of 15 U.S.C. § 1057(b) and constructive notice of the Registrant's claim of ownership under 15 U.S.C. § 1072. Registration Nos. 848,629, 1,747,040, 2,112,912 and 2,461,192 are incontestable, which provides conclusive evidence of their validity under 15 U.S.C. §

1115(b). The marks Winston, Harry Winston and variations referred to in Paragraph 4 are, collectively, the “HARRY WINSTON Trademarks”.

6. Opposer’s HARRY WINSTON Trademarks have become iconic. Upon information and belief HARRY WINSTON is a famous trademark.

7. On April 7, 2008, Applicant’s owner, Jennifer Katherman, filed Application Serial No. 77/441,311 for HAIRY WINSTON for pet supplies. This application went abandoned January 22, 2009.

8. Applicant then filed the application which is being opposed for the composite HAIRY WINSTON Luxury Pet Boutique.

9. Upon information and belief Applicant adopted the name HAIRY WINSTON for her Luxury Pet Boutique in order to intentionally play off of the fame of the Opposer’s famous HARRY WINSTON Trademarks.

10. Upon information and belief, services for which Applicant seeks to register the designation HAIRY WINSTON Luxury Pet Boutique are unrestricted and offered to the same classes of the purchasing public as are the goods produced and services offered by Opposer under its HARRY WINSTON Trademarks.

11. Upon information and belief, the Applicant’s HAIRY WINSTON services will be advertised, marketed and promoted through the same marketing channels and advertising media as the goods produced and services offered by Opposer under its HARRY WINSTON Trademarks.

12. The designation HAIRY WINSTON Luxury Pet Boutique which the Applicant seeks to register is virtually identical to the Opposer’s HARRY WINSTON Trademark. The names “HAIRY WINSTON” and “HARRY WINSTON” look alike and

sound alike and are phonetically equivalent, and given the fame of Mr. Harry Winston and Opposer's HARRY WINSTON Trademarks, no reasonable person could see Applicant's mark "HAIRY WINSTON" without immediately associating it with Harry Winston and Opposer's HARRY WINSTON Trademarks.

13. The Opposer, since long prior to the adoption of HAIRY WINSTON Luxury Pet Boutique by the Applicant, has spent, and continues to spend, large sums of money in the promotion and advertisement of its goods identified and distinguished by its HARRY WINSTON Trademarks, and by reason of such promotion and advertising and the high quality of its products and services carrying the Opposer's trademarks, Opposer now enjoys a valuable goodwill and an enviable and world famous reputation with respect to its trademarks and its goods and services.

14. The distinctive HARRY WINSTON Trademarks have attained widespread public recognition and acquired great value as an identification of the source of goods and services in or by Opposer, and the said marks distinguish Opposer's goods and services from the goods and services of others.

15. The designation HAIRY WINSTON Luxury Pet Boutique, which Applicant seeks to register, consists of Opposer's entire "HARRY WINSTON" Trademark. The addition of the generic and disclaimed words "Luxury Pet Boutique" to Opposer's HARRY WINSTON mark does not differentiate Applicant's mark from Opposer's and reduce the likelihood of confusion; rather it increases the likelihood of confusion among consumers who will immediately associate Applicant's "HAIRY WINSTON" services with the goods and services being produced and sold by Harry

Winston under the HARRY WINSTON Trademark and will falsely presume that there is a connection between the two.

16. The use, promotion and registration of HAIRY WINSTON Luxury Pet Boutique by the Applicant will cause the purchasing public to assume, erroneously, and to be confused, misled and/or deceived, that the Applicant's services originate with, are endorsed, licensed or sponsored by Opposer, or falsely suggest a connection, all to the Opposer's irreparable damage.

17. Applicant's mark is virtually identical to Opposer's name and identity "Harry Winston" and Applicant's mark would be recognized as such; Opposer is not connected with Applicant's activities under its mark; and Opposer's name and identity is of sufficient fame or reputation that when Applicant's mark is used on its luxury pet services, a connection to Opposer would be presumed contrary to the proscriptions of Section 2(a) of the Act.

18. For the reasons set forth in paragraph 1 through 17, Opposer believes, and believing asserts, that the goodwill in its HARRY WINSTON Trademarks will be damaged under Section 2(d) and Section 2(a), and that the Applicant should be denied the registration of the term HAIRY WINSTON Luxury Pet Boutique for all services for which it has made application.

19. Upon information and belief, Applicant's attempt to register the term HAIRY WINSTON Luxury Pet Boutique is likely to cause dilution of Opposer's famous HARRY WINSTON Trademarks under Section 43(c) of the Lanham Act by both: a) blurring in that there will be an association between HAIRY WINSTON and HARRY WINSTON that impairs the distinctiveness of the HARRY WINSTON Trademarks; and

b) tarnishment of the HARRY WINSTON Trademarks for iconic luxury jewelry and retail jewelry services by associating it with Applicant's HAIRY WINSTON trademark for an alleged "Luxury Pet Boutique".

20. By reason of the foregoing, Applicant's application of HAIRY WINSTON Luxury Pet Boutique for retail stores featuring pet supplies is likely to cause confusion with Opposer's mark, falsely suggest a connection with Opposer's founder, Harry Winston, and dilute by blurring and tarnishment the famous HARRY WINSTON Trademarks, and is thus not registrable under Section 13 of the Trademark Act of 1946 (15 U.S.C. § 1063).

WHEREFORE, Opposer respectfully prays that this Opposition be sustained and that application Serial No. 77/684,863 – HAIRY WINSTON Luxury Pet Boutique – be refused registration.

The fee of \$300.00 as provided by *Section 31 of the Trademark Act of 1946* is paid by charging Opposer's attorneys' deposit account.




