REQUEST TO EXTEND TIME TO ANSWER

Saeilo Enterprises, Inc. ("Respondent"), by and through its undersigned counsel, hereby requests a 30-day extension of time, until May 26, 2010, to file an Answer to the Notice of Opposition in this proceeding. Through its undersigned attorney, Respondent is continuing to contact Opposer's attorney to ascertain Opposer's position on the settlement terms Respondent has proposed. The facts supporting this request are as follows:

On February 2, 2010, Respondent proposed settlement via letter emailed by Respondent's counsel to Opposer's counsel. On February 3, 2010, Respondent's

counsel received a "Read Receipt" indicating said email message had been received and opened on that date.

On February 18, 2010, having received no further communication from Opposer, Respondent requested Opposer's consent to a 30-day extension of time to file an Answer.

On February 19, 2010, Opposer's counsel advised Respondent's counsel, via email, that Opposer consented to the extension.

On February 22, 2010 Respondent filed the consented extension request, and the TTAB subsequently granted it.

On March 22, 2010, having received no further communication from Opposer, Respondent's counsel emailed Opposer's counsel and requested (1) Opposer's position on the settlement proposal, and (2) Opposer's consent to an additional extension of time to file an Answer due to ongoing settlement negotiations. Respondent's counsel immediately received a "Read Receipt" indicating said email message had been received and opened on that date.

On March 25, 2010, having received no further communication from Opposer, Respondent's counsel emailed the same request to Opposer's counsel, namely, asking for (1) Opposer's position on the settlement proposal, and (2) Opposer's consent to an additional extension of time to file an Answer due to ongoing settlement negotiations. Respondent's counsel immediately received a "Read Receipt" indicating said email message had been received and opened on that date.

Throughout this period, in addition to email communications, Respondent's counsel has tried to reach Opposer's counsel via telephone. Further calls to the office

of Opposer's counsel were placed on or about April 5, 12, 19, and 26, 2010. Each time, the receptionist answering the phone indicated Opposer's counsel was "not in" or was "in a meeting." Opposer's counsel has not returned or otherwise acknowledged the calls.

To date, Respondent has received no further communication from Opposer. Specifically, Opposer has not indicated its consent or disapproval of the present Request, and Opposer has not indicated its position on settlement.

Under these circumstances, Respondent respectfully requests a 30-day extension of time, until May 26, 2010, to file an Answer in this matter.




